Incident Summary: **** Update May 15, 2022: The suspect in Homicide 2022-0016 has been identified as Dallas W. Lowery M/W/31. A warrant for murder has been filed for the arrest of Dallas Lowery. Mr. Lowery is currently incarcerated in the Delaware Ohio County Jail on unrelated charges.****  ****Update February 24, 2022: The death of the victim, Heather Chapman, is being investigated as a Homicide.****  On February 22, 2022, Patrol Officers responded to the 1700 Block of Melrose Ave on a shooting. Upon arrival, officers located the victim, Ms. Heather Chapman F/W/33, suffering from a gunshot wound. CFD EMS #13 arrived at scene and pronounced the victim deceased at 9:22pm. Due to some suspicious circumstacnces, Homicide Detectives responded to scene and began an investigation.  At this time, Detectives are collecting evidence and are attempiting to determine what happened during this incident. Detectives will be awaiting the coroner's determination of the manner of death.  This incident is still under investigation.
