Incident Summary: **Update - June 9, 2022: The suspect out of Homicide 2021-0178 has been Identified as Imajawon Lamar Johnson M/B/18. Charges were filed for murder, and the suspect is currently incarcerated in the Franklin County Jail.******

On November 24, 2021, Columbus Police Officers were dispatched to the 7000 block of Norworth Rd. on a shooting. Upon arrival, they located the victim, Mr. Jakwan L. Radford M/B/17, suffering from gunshot wounds in front of this location. Mr. Radford was transported to Mt. Carmel East Hospital by Jefferson Township Medic #141 in critical condition. Despite receiving life-saving medical treatment, Mr. Radford succumbed to his injuries and was pronounced deceased at 5:55pm. At this time, investigators are attempting to determine the circumstances associated with this incident. Investigators obtained information that the victim was shot at from motor vehicle that fled the area.
