Incident Summary: ***Update: On June 14, 2022, the suspects from this incident have been identified as Baron N. Anderson and Terrell D. Hicks-Freeman. Arrest warrants have been issued for the murders of Makhy Andrews and Layton Ridgedall. Anyone with information on their whereabouts is asked to call the Columbus Police Homicide Unit at 614-645-4730.***

On June 3, 2022, at approximately 11:00pm, officers were dispatched to the area of N Hamilton Rd and Warner Rd on the report of a shooting. Officers and Columbus Fire Medics arrived at scene and found victim #1 seated in a vehicle with an apparent gunshot wound. Columbus Fire personnel pronounced victim #1 deceased at 11:14pm. Officers were then advised of a second victim in the 5600 Block of Caledonia Rd, where it is believed this incident took place. Officers arrived at scene and found victim #2 laying in the parking lot unresponsive, victim #2 was pronounced at 11:27pm. The circumstances behind this incident are unknown and the investigation in on-going.
