Incident Summary: *Update: On June 14, 2022, the suspects from this incident have been identified as Tahir M. Said and Hanut B. Abdulle. Arrest warrants have been issued for the suspects in the murder of Bryce K. Persang. On Thursday, September 16, 2021, at approximately 5:42 p.m., Officers were dispatched to the area of 5500 Floral Circle South on a report of someone being shot. Officers arrived to the area of Norton Road and Floral Circle South where they discovered a male in the passenger seat of a silver Honda FIT suffering from a gunshot wound. Prairie Township Medics responded and transported the victim to the area hospital where he was pronounced deceased of his injuries.
