Incident Summary: ***Update September 21, 2022: The victim from this incident has been positively identified as Mr. Lance T. Thompson M/B/30. Next of Kin notification has been completed. This incident is being ruled a Homicide, as the Coroner has confirmed the cause of death to be from a gunshot wound. This is the 99 th Homicide Investigation in Columbus, Ohio in 2022.***						
On September 19, 2022, at 12:21pm, Patrol Officers responded to the 1300 Block of E. Hudson St. on a body in a vacant residence. Upon arrival, Officers located a deceased person inside a residence. The unknown person was pronounced deceased at 12:53pm by CFD EMS 13. Due to extenuating circumstances, Homicide team 3 responded and conducted an investigation. At this time, investigators are still attempting to identify the subject. Additional details will be released pending the Coroner's finding of the manner and cause of death.
