Incident Summary: On September 16 th , 2022 at 6:40 pm Suspect #1 and #2 began following victim in the area of Parsons Ave & Williams Rd and waited for victim at a nearby business. As victim walked away from business, Suspect #2 (driver of light tan Jeep Wrangler - model year: 1987-1996) followed victim at which time Suspect #1 (front passenger of Jeep) approached victim on foot, punched victim twice knocking him unconscious then fled in same Jeep.				
Suspect #1 is white male 30-35 years old, 5'9" 160 pounds with dark, long hair in corn-rows wearing red shorts, no shirt with multiple tattoos including: "O. G." upper back with two guns (back to back and pointing downward) between O. G.				
Suspect #2 is white male 30-40 years old, 5'9" 200 pounds with short dark hair and noticeable large tattoo on right side of his neck as well as a tattoo of snake or scroll on left forearm.				

Update:

On September 27th, 2022 Det. Noltemeyer received one public tip as well as calls from Suspect #1 (Ryan Scott Rodgers) and Suspect #2 (Brian K. Fox Jr.) who both provided identification that was corroborated as well as provided statements regarding account of event. Charge of Assault pending for Suspect #1.
