Incident Summary: **Update 11/1/2022****** Blood found on an interior doorknob at the victim's residence as well as DNA recovered from the victim's cane was linked by DNA testing to Miles Jackson. On 4/12/2022, Westerville Police arrested Miles Jackson on outstanding warrants and transported him to Saint Ann's Hospital for medical treatment, and notified Columbus PD who responded to guard him until he could be transported to jail. As Columbus Police Officers were preparing to transport Mr. Jackson, he pulled a handgun and shot at officers. Two Columbus Police Officers as well as Hospital Security Officers shot back and struck Mr. Jackson who died as a result of these injuries. The gun Miles Jackson fired at Officers was forensically tested and determined to be the same firearm responsible for the shooting death of Mr. Williams just two days earlier.

*****UPDATE - 4/13/2021***** The victim has been identified as Ticardo Lawayne Williams and NOK was notified.

On Saturday, April 10, 2021, at 3:42 PM, Columbus Police Officers responded to 2853 Cleveland Avenue to check on the wellbeing of the resident. Officers discovered the apartment was open and found a person dead inside. Signs of foul play were evident and the death is being investigated as a homicide. The identity of the deceased is not yet known. His name will be released once identification is made by the Coroner. Detective Corbin is the lead detective on the case and is being assisted by Detective Shepherd.
