Incident Summary: **UPDATE** On November 21, 2022, Rickey Mackey Jr. was arrested by US Marshalls in the 400 block of Johnson St without incident. He is charged with Murder in the death of Mr. Allen Mullins. He was slated at the Franklin County Jail.					
On November 1, 2022 at approximately 12:27pm, the victim, Allen D. Mullins arrived at OSU East Hospital with a gunshot wound. Despite the lifesaving care provided at the hospital, Mr. Mullins succumbed to his wounds and was pronounced deceased at 2:36pm. Subsequent investigation revealed an altercation occurred between the victim and the suspect in the 1600 block of Harvard Ave During the altercation, Mr. Mullins suffered a gunshot wound. The suspect is identified as Rickey Mackey Jr Charges have been filed against Mr. Mackey Jr. for one count of Murder. Mr. Mackey Jr. is AT LARGE. If he is located, do not approach and call 911 immediately.
