The next item to come before the Board was the review of new **Demolition Contractor** applications.

Mr. Sintic made a motion to certify the results of the applicants who were approved to the Department of Building & Zoning Services for the issuance of a Home Improvement/Demolition Contractor's License. Mr. Kaylor seconded the motion. MOTION CARRIED.

DUE PROCESS HEARINGS

The next item to come before the Board was the Due Process Hearing regarding **Buckeye** Construction, LLC, for the property located at **6440 Sedgemere Lane**. **Paul Caldwell, license holder, was present**. The complaint was filed by the **Cliff Spruill** and the City of Columbus.

The complaint alleged that Buckeye Construction had violated code section 4114.111 — Work as a registered OCILB licensed specialty contractor at the property located at 6440 Sedgemere Lane.

Ken Bruen presented the complaint and the information as provided by Cliff Spruill.

Mr. Caldwell provided testimony and information for the record on behalf of Buckeye Construction. He stated that he was aware that Buckeye Construction made a mistake. The circumstances of the pandemic, the manner in which inspections were being performed and the time constraints put on by the homeowner, it seemed the only answer at the time. He realizes it was a bad decision and will not be doing this again. Buckeye Construction already has a



After discussion and questions by the Board, **Mr. Neverman** made a **Finding of Fact** that **Buckeye Construction** did work without proper authorization at the property located at **6440 Sedgemere Lane**. **Mr. Sintic** seconded.

As to Conclusion of Law, the fact that Buckeye Construction did this work without proper registration/licensing, the Board voted on a motion, by Mr. Neverman, that they are GUILTY of violating City of Columbus Building Code Section 4114.111 - work of a registered OCILB licensed contractor, at 6440 Sedgemere Lane. Mr. Kaylor seconded.

Due to the fact that **Mr. Caldwell** has been properly informed and made aware of the violations he has been guilty of violating, and that if he is before the Board again for any similar violations, these will remain in his record and will be held against him, **Mr. Neverman** made a motion to **TAKE NO ACTION** against **Buckeye Construction's license**. **Mr. Kaylor** seconded.
