Incident Summary: ***Update March 27, 2023: The suspect, Malike Miller, was apprehended without incident on March 24, 2023. Malike Miller was slated for Murder and Weapons Under Disability.***			
Update March 14, 2023: The suspect in this homicide has been identified as Malike Miller M/B/22. A warrant for murder has been filed for his arrest.			
****Update March 3, 2023: The victim of this Homicide has been identified as Mr. Jared B. Porter M/W/23YOA. Next of Kin notification has been completed.****			
On March 3, 2023, at 4:22am, Patrol Officers responded to the 3000 Block of S. Hamilton Rd, on a shooting. Upon arrival, the officers located the victim inside the business suffering from a gunshot wound. Medic #181 transported the victim to a local area Hospital in critical condition. Despite receiving life-saving medical care, the victim succumbed to his injuries and was pronounced deceased at 5:41am. Investigators are still attempting to identify a suspect and the circumstances that led to this incident. The identity of the victim will be released once next of kin notification has been completed.			
This incident remains under investigation.
