| Incident Summary: On May 6, 2023, at 2:11pm, the suspect from this incident was pronounced deceased from a self inflicted gunshot wound sustained on the night of the incident. | | | |

On May 6, 2023, at approximately 3:31am, officers were dispatched to the 1400 block of St Clair Ave on the report of a shooting. Officers arrived at scene and found several individuals suffering from gunshot wounds. Victim #1 was pronounced deceased by CFD EMS 13 personnel at 3:41am. Victims #2- #5 were transported to local hospitals for treatment for their injuries and are expected to survive. Victims #6 and #7 were inside the residence during the incident but were not injured. Victim # 8's house was damaged by the gunfire and he was not injured.

Victim #4 is D.P. F/B 20, Victim #5 is T.R. F/B 53, Victim # 6 T.P. F/B 24, Victim #7 J.M. F/B 21 and Victim #8 is F.S. M/B 63.
