Incident Summary:

7th UPDATE: On June 2, 2023, the Franklin County Grand Jury indicted Tommie Wilkerson Jr. on four counts of Felonious Assault for his role in this incident. Wilkerson was already incarcerated in the Franklin County Jail on unrelated matters when this indictment was issued. The investigation into Mr. Sobnosky's death continues. 6th UPDATE: On December 1, 2022, CPD Patrol officers arrested Tyyaun Sullivan M/B 19, in the 3200 Block of Rabbit Hill Lane on the Far East Side for his outstanding warrants. He was taken to the Franklin County Jail on the above charges. The investigation into Mr. Sobnosky's death continues. 5th UPDATE: Detectives have filed a warrants charging 19-year-old Tyyaun Sullivan with three counts of Felonious Assault. Anyone who knows Sullivan's whereabouts is asked to contact police. The investigation into Sobnosky's death is ongoing. Anyone with information regarding this incident, is asked to call the Columbus Police Homicide Unit, Detective Polgar, at (614) 645-4196 or Central Ohio Crime Stoppers at (614) 461-TIPS (8477).

4th UPDATE: On Sunday, November 13, 2022, Keimariyon Ross turned himself into the Franklin County Jail. The investigation into Sobnosky's death is ongoing. Anyone with information regarding this incident, is asked to call the Columbus Police Homicide Unit, Detective Polgar, at (614) 645-4196 or Central Ohio Crime Stoppers at (614) 461-TIPS (8477).

***3rd UPDATE: Detectives have filed a warrant charging 18-year-old Keimariyon Malachi Demetrish Ross with Murder for causing Sobnosky's death. Anyone who knows Ross's whereabouts is asked to

contact police. The investigation into Sobnosky's death is ongoing and investigators anticipate filing additional charges.***

2nd UPDATE: Detectives have obtained photos and video of the incident. They have identified twelve (12) persons of interest in this case. Please contact Det. Polgar at (614) 645-4196 or Crimestoppers at (614) 461-TIPS (8477) if you recognize any one in these photos. Associated videos from the incident will be released at a later time.

UPDATE: The previously unnamed victim was 21-year-old Kevin Sobnosky. On October 30, 2022, at 4:17PM, Sobnosky succumbed to his injuries and was pronounced deceased. The investigation into Sobnosky's death is ongoing.

Additional Victim: D.V. M/W 21

On October 30, 2022, the listed victims were driving in the area of the 1400 block of North Cassady Ave when their vehicle was struck by gunfire coming from the parking area of a local business. Victim K.S. was struck by a bullet. Victim K.S. was transported to a local hospital where he is currently being treated for his injury. Due to the severity of that injury, the CPD Homicide Unit is investigating. The other victims were occupants of the same vehicle. No suspects have been identified at this time.
