

## Eligibility Requirements

To be eligible for a senior discount on a City of Columbus electricity bill, the customer must meet the requirements below. Those approved will receive a 10% discount on consumption charges, but not less than the minimum monthly charge.

- Be 60 years of age or older.
- Have an active City of Columbus electricity account in your name (or spouse's name).
- Live in a single family home with one electric meter.
- Household income must be less than 150% of the current U.S. Bureau of Census federal poverty level. Total household income for last year must meet the guidelines on the chart below.

*Please note: do not include disability payments paid by the V.A. or any branch of the U.S. Armed Forces when calculating total income.*

## Other Information

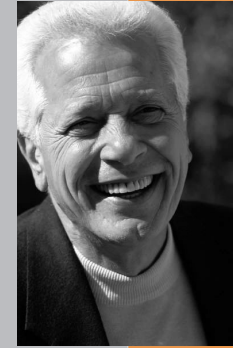
If a customer becomes ineligible for the discount because their household income no longer meets the requirements, Customer Service must be notified as soon as possible, but no later than 30 days after the ineligibility.

Be aware that falsifying information or failing to notify a change in eligibility status may lead to:

- Termination of electric service
- Recovery of past discounts
- Civil and/or criminal sanctions
