#### Statement of Hardship for 1155 Bonham Avenue

#### Hardship Narrative

The owner, Liza Wilson is requesting a variance to obtain a Junk Yard/Salvage License Permit to operate a bulk sales new and recycled materials commercial landscape supply business. The property at 1155 Bonham is the result of a lot split of 999 Bonham. The address lies within an M (manufacturing) zoning district. The property 999 Bonham has housed legal use for the al least the last 100 years and is presently being used for steel fabrication, storage, and sales commercial business. It is a reasonable assumption that when the use was established more that a 100 years ago the property was outside of the then city limits. As the city grew up to, around, and beyond the site residential zoning was codified. Parenthetically, Board of Zoning Adjustment granted a variance for 1177 Bonham, the neighbor to the east for a Junk Yard/Salvage License with in the last five years.

#### 33307.09 Variance by Board

- The special circumstance of the City of Columbus growing up to, around and beyond the specifically applies to 1155 Bonham was not generally a result of the past owners of the last 100 years actions and specifically in no way of the present owner of 999 Bonham and/or the petitioner of this Statement of Hardship, Liza Wilson.
- The above special circumstances make is necessary for the petitioner to request variances as described under the Board of Zoning Adjustment Application, Special Permit as listed above on this application.
- 3. The applicant is asking you just consideration and awarding of a Junk Yard/Salvage License Permit as was awarded to the property described as 1177 Bonham Avenue in the near recent past.
- 4. The granting of this variance will not be injurious to the neighboring properties as was previously deemed by the Board of Zoning Adjustment for 1177 Bonham. In addition, the petitioner, Liza Wilson, is ready, willing, and able to accommodate and implement any and all directives specifically mandated by the Board of Zoning Adjustment for 1155 Bonham Avenue.


