Chairman Snedeker then called the meeting to order at 5:00 PM.

---MINUTES---

The Chairman asked the Secretary if the minutes of the previous meeting were ready for the Board. The Secretary responded that the minutes of the March 12, 2014 meeting had been prepared. Mr. Teaford made a motion to accept the minutes as written. Mr. Burkett seconded the motion. Motion approved (6 yes and 0 no). There were no further questions and the Chairman moved on to the next order of business.

----GUESTS----

The Chair asked if there were any guests in attendance for this meeting. There were no guests.

----GENERAL BUSINESS-----

At this time, the Chair opened the floor for any general business.

The next item on the agenda was a due process hearing regarding the City of Columbus vs. David Diehl, DA Electrical, Inc., #E2584, for a property located at 339 N. Front Street. Mr. Diehl was charged with violating Columbus Building Code Section 4113.73, Electric Permits Required. He was present for the meeting. Gerry Tudor stated Cliff Honeycutt went to this address on 4/1/14 to perform an inspection for another electrical contractor. He further stated while Mr. Honeycutt was there, he observed Mr. Diehl installing a receptacle without a permit. Mr. Diehl stated he went to look at the job and made the decision to go ahead and install the receptacle without a permit because it was a quick job, and he was planning on getting the permit when he finished. Mr. Tudor stated Mr. Diehl did obtain the permit and pay the associated fees, and the inspection has been approved. He further stated Mr. Diehl was found guilty of working without a permit by the Board on September 11, 2013, however, no action was taken against his registration at that time. Ms. Moorehead made a motion to find that Mr. Diehl did work without a permit at this address. Mr. McGatha seconded the motion. Motion approved (6 yes and 0 no). Mr. Shaner made a motion to find Mr. Diehl guilty of violating Columbus Building Section 4113.73. Mr. Landers seconded the motion. Motion approved (6 yes and 0 no). Ms. Moorhead made a motion to suspend Mr. Diehl's registration for thirty (30) days. Mr. Burkett seconded the motion. Motion approved (4 yes and 2 no).

At this time the Chair opened the floor for any old business that may be pending.

Gerry Tudor stated that plans have been made to move the Department of Building & Zoning Services downtown in 2017.

There being no further old business, the Chair moved to the next item on the agenda.
