The next item to come before the Board was the review of a new Demolition Contractor application.

Mr. Miller made a motion to certify the results of the application reviewed and recorded by the Secretary to the Department of Building & Zoning Services for the issuance of the appropriate Demolition Contractor's registration. Mr. Appeldorn seconded the motion. **MOTION CARRIED.**

The next item to come before the Board was a due process hearing regarding Betty Burnside and the City of Columbus vs. William Jervis, HIC5358, for a property located at 948 Stephen Drive. Mr. Jervis was charged with violating Columbus Building Code Sections 4113.37(B), Building Permits Required, 4115.01, Inspections Required, 4115.03, Approvals Required, and 4114.111, Work of a Licensed Specialty Contractor. Mr. Jervis and Ms. Burnside were both present for the meeting as well as Megan Burnside, daughter of the complainant who also resides at this address. Etherington, City of Columbus Structural Field Supervisor, stated Ms. Burnside filed this complaint on February 3, 2014 due to work performed by Mr. Jervis' company, Affordable Anytime Repair and Cleaning Services, for a frozen water line which burst in her garage. He further stated the pipes broke on three separate occasions, which caused damage to the drywall in the ceiling. Megan Burnside stated the problem persisted because they did not use the shut off valves in the garage. Mr. Etherington stated Mr. Jervis did not obtain a permit to replace the drywall nor did he obtain a plumbing permit for the water pipe repair due to the fact he does not have a plumbing license in the City of Columbus. Mr. Jervis stated this was an emergency repair and all he did was install a sharkbite. David Daniel, City of Columbus Structural Supervisor, stated this repair would have required a permit and should have been done by a licensed plumbing contractor. Mr. Jervis became irate and was asked to leave the proceedings. Mr. Miller made a motion to find that Mr. Jervis did perform work at this address for which he was not properly licensed and did not obtain the proper permit for the drywall nor have any inspections. Mr. Appeldorn seconded the motion. MOTION CARRIED. Mr. Miller made a motion to find Mr. Jervis guilty of violating Columbus Building Code Sections 4113.37(B), Building Permits Required, 4115.01, Inspections Required, 4115.03, Approvals Required, and 4114.111, Work of a Licensed Specialty Contractor. Mr. Appeldorn seconded the motion. MOTION CARRIED. Mr. Miller made a motion to suspend Mr. Jervis' license for 30 days. After discussion, Mr. Miller amended his motion to suspend Mr. Jervis's license for 90 days. Mr. Appeldorn seconded the motion. MOTION CARRIED.

The next item to come before the Board was a due process hearing regarding Douglas Summers and the City of Columbus vs. Norwood Freeman, HIC6284, for a property located at 1498 Southfield Drive. Mr. Freeman was charged with violating Columbus Building Code Sections 4113.13, Working Without a Permit Fee and 4114.111, Work of a Licensed Specialty Contractor. Mr. Freeman was present for the meeting, however, Mr. Summers was not. Ken Etherington, City of Columbus Structural Field Supervisor, stated Mr. Summers entered into a contract with Mr. Freeman on April 4, 2013 for the construction of a room addition and a detached garage. He further stated Mr. Summers terminated the contract on February 17, 2014 and filed this complaint. He also stated there was considerable electric work done without a permit. David Daniel, City of Columbus Structural Supervisor, stated on April 17, 2014, a structural inspection was performed at this address and a list of violations were discovered, however, the issue before the Board was the fact that an electric permit was not obtained. Mr. Freeman stated he subcontracted this work to Keith Speed, Speed's Electric. Mr. Speed stated he did not pull a permit, however, he did contact Gerry Tudor, City of Columbus Electric Inspection Supervisor, and advised him that this work was going to commence. He further stated before he could pull the permit, the homeowner terminated Mr. Freeman's contract. Mr. Daniel stated this work would not have been considered an emergency repair. Mr. Miller made a motion to find that Mr. Freeman did not violate any of the Code sections mentioned, and therefore, no action will need to be taken against Mr. Freeman's license. Mr. Pione seconded the motion. MOTION CARRIED.

Mr. Neverman moved to adjourn. Mr. Pione seconded the motion. **MOTION CARRIED.** Adjourned at 3:00 p.m.
