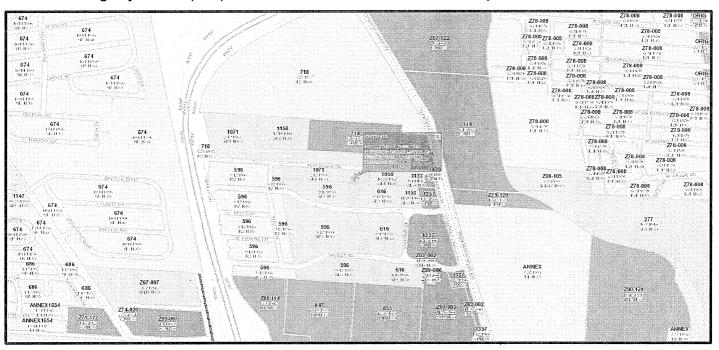

The Code states, "Minimum Distance from Street Property Line: That distance equal to one-half of the designated right-of-way width of the frontage street as shown on the Columbus thoroughfare plan or if the street is not shown thereon, 25 feet."

This application proposes a reduction of the established 25 feet Front Yard Setback to 8 feet. The reduction of the Front Yard Setback is to accommodate the relocation of the existing dumpster pads. The request for this Variance is prompted by CIP which is under construction along Riverview Drive.

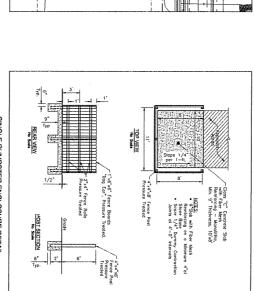
In compliance with Columbus City Code 3307.09 we offer the following:

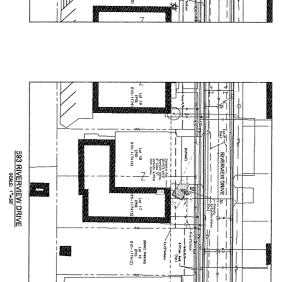
- 1. That special circumstances or conditions apply to the subject property that do not apply generally to other properties in the same zoning district.
 - This site has operated with non-conforming dumpster pads located directly adjacent to the Rights-of-Way of Riverview Drive for duration of the current ownership. The fact that the dumpster pads are non-conforming has required private refuse hauling rather than utilizing City Services for this site.
- 2. That the special circumstances or conditions are not the result of the actions of the property owner or applicant.
 - As stated above, the City is in the process of construction of a CIP for Riverview Drive. This CIP affects the frontage along the subject property. As a result of the CIP, the existing dumpsters will have to be relocated.
- That the special circumstances or conditions make it necessary that a variance be granted to
 preserve a substantial property right of the applicant which is possessed by owners of other property
 in the same zoning district.
 - Currently there are only twelve (12) off-street parking stalls for the entire site. If the new dumpsters were to be relocated beyond the 25' Front Yard Setback, it would adversely affect the parking conditions for this development. In addition, locating the dumpsters in the existing parking area would require excessive maneuvering for the City Refuse Department.
- 4. That the grant of a variance will not be injurious to neighboring properties and will not be contrary to the public interest or the intent and purpose of this Zoning Code.
 - To grant this variance would improve the existing condition of this site and the streetscape as a whole while maintaining the integrity of the on-site parking. The application is proposing the relocation of the existing dumpster pads to have a greater separation form the existing Right-of-Way. In addition, it proposes to bring the dumpster pads up to code with appropriate construction and screening.



SINGLE DUMPSTER ENCLOSURE DETAIL

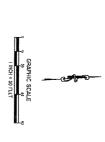

My Attorney-in-fact may not delegate any authority granted under this document.

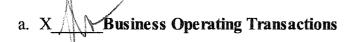
5. Liability of Attorney-in-fact
