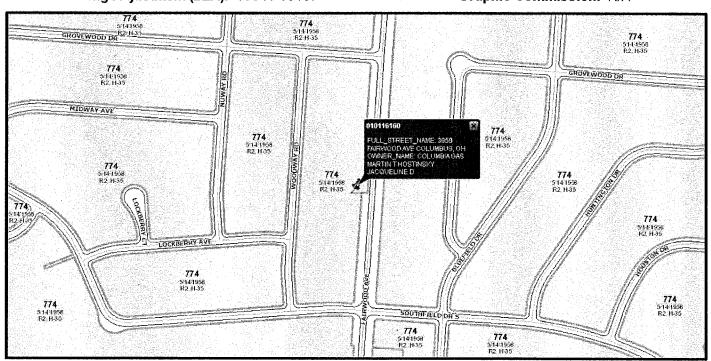

3307.09 Variances by Board.

APPLICATION #

- A. The Board of Zoning Adjustment shall have the power, upon application, to grant variances from the provisions and requirements of this Zoning Code (except for those under the jurisdiction of the Graphics Commission and except for use variances under the jurisdiction of the Council). No variance shall be granted unless the Board finds that all of the following facts and conditions exist:
  - 1. That special circumstances or conditions apply to the subject property that does not apply generally to other properties in the same zoning district.
  - 2. That the special circumstances or conditions are not the result of the actions of the property owner or applicant.
  - 3. That the special circumstances or conditions make it necessary that a variance be granted to preserve a substantial property right of the applicant which is possessed by owners of other property in the same zoning district.
  - 4. That the grant of a variance will not be injurious to neighboring properties and will not be contrary to the public interest or the intent and purpose of this Zoning Code.
- B. In granting a variance, the Board may impose such requirements and conditions regarding the location, character, and other features of the proposed uses or structures as the Board deems necessary to carry out the intent and purpose of this Zoning Code and to otherwise safeguard the public safety and welfare.
- C. Nothing in this section shall be construed as authorizing the Board to affect changes in the Zoning Map or to add to the uses permitted in any district.

I have read Section 3307.09, Variances by Board, and believe my application for relief from the requirements of the

Zoning Code satisfies the four criteria for a variance in the following ways:

Columbia Gas Transmission, LLC ("Columbia") is working on a project to improve its regulator station on Fairwood Avenue. As part of this process, Columbia will be razing the existing structures and constructing new structures on the property with improved natural gas infrastructure. One of the structures Columbia is building is a canopy on the southern portion of its property. Due to the placement of Columbia's interstate natural gas infrastructure, Columbia is requesting two variances for the placement of this canopy. First, Columbia is requesting a variance of Columbus City Code Section 3332.26(B) to place the canopy within 4 feet, 7 inches of the side lot line. Second, Columbia is requesting a variance of Columbus City Code Section 3332.21 to place the canopy within 17 feet of the public right-of-way line.

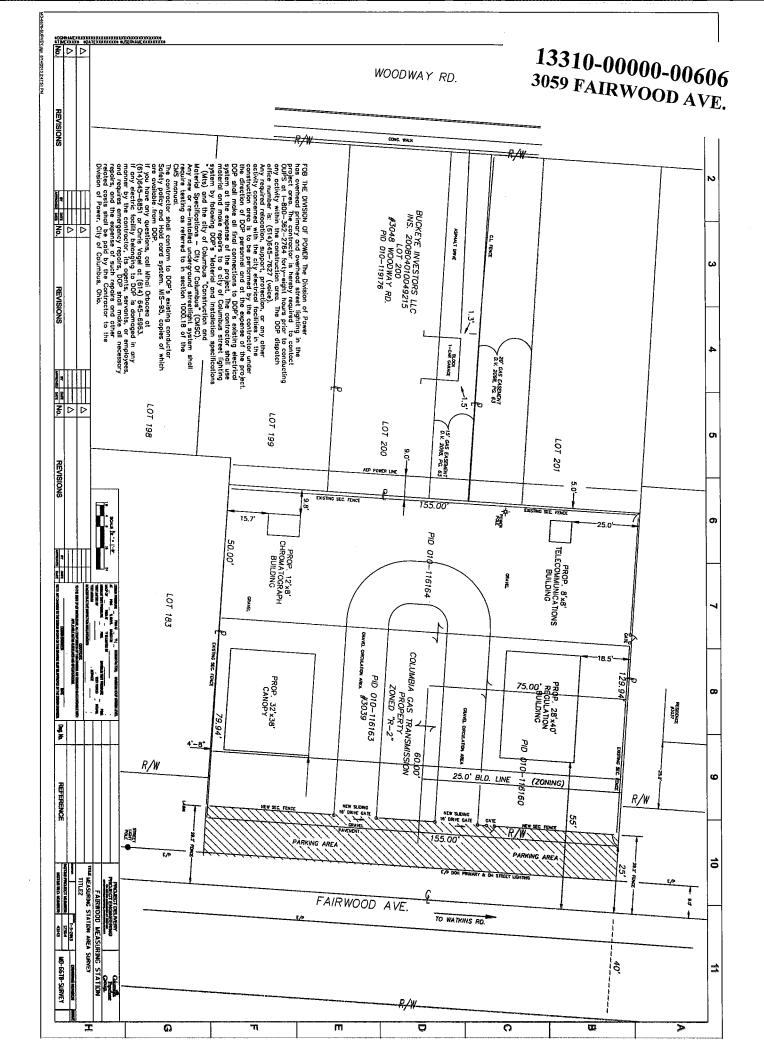
