Introduction

The City of Columbus is proposing use of Program Year 2021 funding allocated by the U.S. Department of Housing and Urban Development. The funding is planned for expansion of existing programming and new programming to serve low-to-moderate income residents of Columbus. Expenditures are consistent with community needs, priorities and strategies stated in the City's 2020-2024 Consolidated Plan. The City will receive allocations from the Federal Government for the Community Development Block Grant (CDBG) program which primarily benefits low-income individuals, the Housing Opportunities for Persons with AIDS (HOPWA) program, the HOME Partnership (HOME) program which funds affordable housing opportunities and the Emergency Solutions Grant (ESG) program which provides homelessness prevention and shelter assistance.

The City is budgeting for these programs based on entitlement awards announced by HUD, program income, and funds recaptured from a Revolving Loan Fund.

Public Participation Process

First Public Comment Period for the 2021 Action Plan and Budget:

A thirty (30) day public comment period began on October 26, 2020 when a draft Action Plan Summary was presented at the Columbus City Council Meeting. The document was made available on the City's Department of Finance and Management, Grants Management Division webpage. Public comments were accepted through November 25, 2020 via phone, email and in writing. No public comments were received.

Public Hearing: the Department of Finance and Management, Grants Management Division with other City department representatives and City Council held a virtual public meeting on November 17, 2020 at 3:00 PM. Each project included in the draft plan was discussed and there was one citizen testimony. The meeting was virtual due to social distancing protocol during the COVID-19 pandemic.

Second Public Comment Period for the 2021 Action Plan and Budget:

A thirty (30) day public comment period began on April 25, 2021 when the 2021 Action Plan and this document (Action Plan Summary) was made available on the City's Department of Finance and Management, Grants Management Division webpage. Public comments are accepted through April 25, 2021 via phone, email and in writing.



Public Hearing: City Council will present and authorize the submission of the 2021 Action Plan for the City of Columbus during a regular City Council Meeting on April 19, 2021.

Community Development Block Grant Programing

Goal: Provide Educational / Recreational Youth Programing

1.) **Columbus Recreation and Parks Department Capital Kids**

\$630,000

The Capital Kids program incorporates trained staff, state of the art technology, high expectations and high performance standards designed to gauge student's academic achievement and to also provide participants with a safe place to learn and play when school is out.

2.) **Columbus Recreation and Parks Department Fitness Camps**

\$90,000

Provide a camp for children ages 6 to 14 years that operates during the summer & winter when school is not in session. The School's Out program is designed to especially benefit the children of working parents. 464 ADA compliant curb ramps at 95 intersections in the Hilltop, Morse/161, Near East, Near South, and South Linden areas. Existing roads, alleys, sidewalks, and other existing infrastructure components that are impacted by this project will be repaired/replaced as necessary.

6.) **Park Improvements and Tree Planting**

\$2,280,000

Park Improvements at: Marie Moreland Park, Smith Road Park, Maybury Park, Livingston Park, Nelson Park, Sullivant Gardens Park, Waltham Woods Park, Hilliard Green Park, Kingsrowe Park, Mifflin Park, Redick Park, Hilltonia Park, Kobacker Park, Millbrook Park, Hauntz Park, Southwood Park. Street Tree Planting in CDBG-eligible block groups within the North Central, South Side, Far South and Southwest Columbus Communities.

7.) **Neighborhoods Sidewalk Improvements**

\$1,400,000

Sidewalks will be installed on the following streets: East North Broadway, Wicklow Road, Barnett Road, Steele Avenue and Woodward Avenue.

8.) **Glenwood and Windsor Pool Designs**

\$1,000,000

The Columbus Recreation and Parks Department will administer an architectural and engineering contract(s) for Glenwood Pool and Windsor Pool. The development of the design will position Columbus Recreation and Parks for the next phase of the project, replacement of the existing pools with the modern outdoor aquatic facilities appropriate for current and future aquatics programs.

9.) **Wheatland Avenue Street Improvements Design**

\$300,000

New development continues on the Hilltop's Wheatland Avenue. CDBG will be utilized to design infrastructure improvements to the street to better serves residents.

10.) **Tennis Court Lighting Improvements**

\$420,000

The Columbus Recreation and Parks Department will contract the installation of energy-efficient LED lighting at Marion Franklin Park and Scioto Southland Park.

ESG-funded Direct Housing programs provide services and financial assistance to families exiting emergency shelter programs into their own homes, with the goal of long-term stabilization. The 2021 ESG program will assist an estimated 4,000 persons.

The development of the design will position Columbus Recreation and Parks for the next phase of the project, replacement of the existing pools with the modern outdoor aquatic facilities appropriate for current and future aquatics programs.

8.) **Wheatland Avenue Street Improvements Design**

\$550,000

New development continues on the Hilltop's Wheatland Avenue. CDBG will be utilized to design infrastructure improvements to the street to better serves residents.

9.) **Tennis Court Lighting Improvements**

\$420,000

The Columbus Recreation and Parks Department will contract the installation of energy-efficient LED lighting at Marion Franklin Park and Scioto Southland Park.



10.) **Arts and Fitness Facilities Upgrades**

HUD Community Development Block Grant***

A. Substantial Amendment Project and Budget Changes

At the request of the Department of Development, The City of Columbus' (the City) U.S. Department of Housing and Urban Development (HUD) Fiscal Year (FY) 2021 Community Development Block Grant (CDBG) funding needs have been reassessed. A third substantial amendment to the FY 2021 HUD Annual Action Plan is required to propose changes to projects and funding allocations for CDBG grant dollars.

1.) Critical Home Repair Services

- The Department of Development, Housing Division, will utilize other funding to deliver Critical Home Repair Services for residents in need. The City proposes the cancellation of the 2021 Critical Home Repair Services FY 2021 CDBG program.

2.) Roofing Repair Services

- The Department of Development, Housing Division, will utilize the \$400,000 in FY 2021 CDBG funding from the cancelled FY 2021 CDBG Critical Home Repair Services program to increase the budget of the City's Roofing Repair Services program to \$845,000.

B. Citizen Participation

The City started a 30-day public comment period on June 27th, 2022 to gather feedback on the proposed change. This summary of projects was posted on the City's Grants Management webpage and public notice was published in the Columbus Dispatch.
