Officer Acknowledgments

Dr. Ford read a statement regarding the CPRB recognizing citizens compliments about Officers worthy of commendations for outstanding service. Dr. Ford's statement was specifically about CPD Officers heroic actions during a truck accident that took place on November 13th. There were three officers on the scene who helped rescue a citizen from the burning truck.

Review of 2nd Quarter Response from CPD

The Civilian Police Review Board received a written response from the CPD regarding the recommendations that they have made to the CPD over the course of the year during their monthly board meetings. The CPRB reviewed the response, any questions/comments are listed below in the Questions and Recommendation section.

Questions and Recommendations from the Civilian Police Review Board

- A case involving a custody dispute where the officers misread legal documentation, because of this error the child was removed from the custodial parent. The CPRB wanted to know what type of training does the CPD established for interpreting legal documents. CPD does receive training on Domestic Violence documentation, but not Domestic Custody Orders.
- **Recommendation:** The CPRB recommends that the CPD receive training on how to properly distinguish between the most common court documents that they may encounter while on patrol.
