Incident Summary: On the listed date and time, CPD Patrol officers responded to the report of a traffic crash at the intersection. Upon arrival, the driver of the vehicle was found to be suffering from a gunshot wound. He was transported to Grant hospital in critical condition and was subsequently pronounced deceased at 8:20pm. The motive in the crime is unknown at this time. Homicide detectives are investigating.

Update #1-The victim in this case has been positively identified by the Franklin County Coroner's Office as listed above. NOK has been notified. Homicide Detectives continue to investigate.

Update #2: On April 15, 2025, CPD SWAT arrested two suspects, Ronell Brightwell M/B 16 and Arness Morris M/B 15 without incident for this crime. Each suspect was charged with Murder and taken to the Juvenile Detention Center.

Update #3: On April 16, 2025, the third identified suspect in this case, Deshawn Crocket, M/B 15, was charged with Murder. He was arrested on the west side of Columbus by CPD SWAT without incident and taken to the Juvenile Detention Center.
