Incident Summary: ***Update: On January 15, 2025, Devon R. Ford was arrested in the 2700 Block of Grasmere Ave for the murder of Abdulrahman Mohamed. He was processed at Columbus Police Headquarters and slated at the Franklin County Jail.***			
Update: On Monday November 11, 2024, victim #1 has been identified as, Abdulrahman Mohamed, next of kin notification has been made.			
On Saturday, November 9,, 2024, at approximately 8:21am, Columbus Police Officers were dispatched to the area of Fitzroy Dr and Walford St on the report of a shooting. On arrival, officer found two victims suffering from apparent gunshot wounds. Clinton Township Medic #61 transported victim #2 to a local hospital in critical condition, Columbus Fire Medic #24 personnel pronounced victim #1 deceased at scene at 8:27am. Detectives have filed a warrant for Mr. Devon R. Ford for the muder victim #1.
