Incident Summary: On May 1, 2025, at approximately 10:15 a.m., Columbus Police Patrol Officers (CPD) and Columbus Division of Fire Medics (CFD) were dispatched to the 1000 block of Ellsworth Avenue to check on the wellbeing of a young juvenile. Upon arrival, officers learned the juvenile victim was left at the residence the previous night by an individual only identified as "Nate." The responding officers observed the victim had visible significant external injuries and was transported to Nationwide Children's Hospital (NCH) for treatment.

After being examined at NCH it was determined the victim had sustained serious, potentially life-altering injuries, and was in critical condition.

Detectives from the Physical Child Abuse Unit (PAU) responded and initiated an investigation. With the assistance of the New Albany Police Department and the Fairfield County Sheriff's Office, PAU Detectives identified Mr. Nathan Lee Bridges as the primary suspect in this invesitgation.

On May 13, 2025, PAU Detectives filed a warrant for the arrest of Mr. Bridges. At approximately 4:00 p.m. Mr. Bridges was arrested by CPD S.W.A.T. Officers without incident. Mr. Bridges is currently incarcerated at the Franklin County Corrections Center.
