Incident Summary: On April 13, 2025, at approximately 3:25AM, Columbus Police Patrol Officers responded to the 4000 block of Migration Lane on a report of an unresponsive child. Upon arrival they located the victim, Eva Bretz, and immediately began CPR. The victim was transported to a local hospital by Clinton Township Medic 61 personnel in critical condition with significant internal and external injuries. Despite all efforts by everyone involved, the victim was pronounced deceased at 10:14 AM on April 13, 2025. Next of kin have been notified.

Eva Bretz's death was determined to be a homicide and based on the resulting investigation, warrants were filed against Ashley Fagan (Bretz's mother) and Blake Hutchinson, Fagan's current boyfriend, for Endangering Children-Child Abuse and Murder.

On May 5, 2025, Ashley Fagan was arrested without incident on her warrants. On May 6, 2025, Blake Hutchinson took his own life when approached by Knox county SWAT personnel when he attempted to leave the residence where he had been staying. Knox County SWAT had been surveilling the residence based on information obtained during the investigation.
