Incident Summary:
On April 11, 2024, at 5:17 PM, Columbus Police officers were dispatched to the 1000 block of E. 21st Av. on a shooting. Upon arrival, the officers found one victim, identified as KRISTION GRESHAM, M/B/21, suffering from a gunshot wound. Mifflin Twp. Fire medics arrived and transported Gresham to a local hospital. Gresham is expected to survive his injuries. At 5:44 PM, officers were dispatched to the 2000 block of Kenny Rd. to investigate a shooting victim who was privately transported to that location. Upon arrival, the officers found DELVON WILKERSON, JR., M/B/21, suffering from a gunshot wound. Columbus Fire medics arrived and transported Wilkerson to a local hospital, where he was pronounced deceased at 6:13 PM. Next of kin notification has been made.

The preliminary investigation revealed an altercation occurred involving Gresham and Wilkerson on E. 21st Av. resulting in gunfire. The motive is undetermined and the investigation continues.
