**Incident Summary: \*\*\*UPDATE 8/29/2024\*\*\*** On August 29, 2024, US Marshals/SOFAST personnel arrested Jaquez Hoover on his warrants without incident in the 4600 block of Glengate Drive. The victims and their families have been notified.

**\*\*\*UPDATE 8/20/2024\*\*\*** The Columbus Division of Police is seeking assistance from the public in locating Jaquez Hoover regarding this double homicide. Anyone with knowledge of Mr. Hoover's whereabouts is asked to call the Columbus Police and not approach him directly. Mr. Hoover should be considered armed and dangerous.

Photos from the time of the incident as well as prior photos are included.

**UPDATE 6/15/2024:** Based on information obtained following the release of the surveillance video images, warrants were filed against Mr. Jaquez Hoover for two counts of Murder. Mr. Hoover remains at large.

On June 14, 2024, at approximately 1:45AM, Columbus Police Patrol officers were dispatched to the 200 block of N. 5<sup>th</sup> Street on a report of a shooting. Officers arrived at the scene and found 4 victims suffering from apparent gunshot wounds. The officers rendered aid to the victims until CFD Medic personnel arrived. CFD Medic 1 personnel pronounced Mr. Desmond Taylor deceased at scene at 1:58 AM. Mr. Ceilin Richard Peakes Smith was transported to a local hospital by CFD Medic personnel, and despite all efforts by medical staff, was pronounced deceased at 2:45 AM. Next of kin for both deceased have been notified.

Two additional adult victims were transported by CFD to local hospitals and are expected to survive their wounds.

**Investigators are asking for assistance to determine the identities of several persons of interest related to this incident. Please see attached photos of the individuals taken from surveillance cameras.**
