Incident Summary:

*** UPDATE: On December 7, 2024, suspect BRANON PETERSON, JR., age 19, was arrested on a previously filed warrant charging him with murder. This investigation is ongoing. ***

On November 22, 2024, at 1:01 PM, Columbus Police officers were dispatched to the 2900 block of Southfield Dr. on a reported shooting. Upon arrival, the officers found one victim, identified as RAHEEM DAWKINS, age 18, suffering from a gunshot wound. Columbus Fire medics arrived and transported Dawkins to a local hospital, where he was pronounced deceased at 1:32 PM. Next of kin notification has been made.

Another adult male identified himself at the scene as the person who shot Dawkins. The adult male, whose identity is being withheld at this time, claimed self-defense after being assaulted by Dawkins. The preliminary investigation did not reveal a specific motive. The investigation continues and the adult male is cooperating with detectives.
