**Incident Summary: \*\*\*Update: February 21, 2024, the Columbus Police Homicide Unit is asking for help from our community partners in identifying the owners of these two vehicles. The vehicles were seen leaving the immediate area after the double homicide outside of the Noir Lounge in the 100 block of W. Cherry St. in the early morning hours of February 5, 2024.**

**\*\*\*Update: February 6, 2024, the victims in this incident have been identified as Nigel L. Jackson Jr. and Percell E. Scott III. The next of kin notification has been made.\*\*\***

**On February 5, 2024, at approximately 1:15am, officers were dispatched to the 100 block of W. Cherry St. on a shots fired call. Officers arrived at the scene and found two individuals suffering from gunshot wounds. The officers rendered aid until Columbus Fire Medic #2 arrived, at which point both subjects were pronounced deceased at 1:25am. The names of the victims are being withheld pending notification of the next of kin.**
