Incident Summary: Update #2: As of March 18, 2024, all listed suspects in this Homicide were arrested by the Columbus Police SWAT team without incident. George Garrett M/B 29 is also charged with Obstructing Justice (Harboring) F-3. The suspects were both taken to the Franklin County Jail.

On Sunday, February 11, 2024, at 5:21AM, Columbus Police Officers were called to the 1300 block Beechwood Rd. on a report of a shooting. On arrival, officers found Dante Gamble, 39, suffering from an apparent gunshot wound. CFD Medic 823 transported Gamble to Mount Carmel East Hospital in critical condition, where he was pronounced deceased at 6:00AM.

Gamble was patronizing an after-hours club at this location. The venue was closing and Gamble was in the parking lot and appeared to be preparing to leave, when gunfire erupted and Gamble was struck. Following the shooting, while a few patrons attempted to aid Gamble, a number of other patrons can be seen on video leaving prior to police arrival. Investigators are asking anyone who was present, who has not be interviewed by a detective, to contact Detective Johnson.
