**\*\*\* Update: May 1, 2024, detectives have identified the suspect in this case as Jaquan Curry and have issued a warrant for his arrest. Detectives also need to identify three additional persons of interest and are asking for assistance from our community partners. **On April 29, 2024, patrol officers were dispatched to the 1700 block of N. High St. on the report of a fight and shots fired. Upon arrival, they found an individual suffering from an apparent gunshot wound. Officers provided aid to the victim until Columbus Fire Medic #7 arrived and took over care. Victim #1 was transported to a local hospital in critical condition. Despite receiving life-saving medical care, victim #1 was pronounced deceased at 3:06 a.m. Victim #2 and victim #3 were assaulted during the fight and were treated at a local hospital as well.**
