Incident Summary: \*\*\*\*Update 11.21.2024: The victim of this offense has been identified as Darreion Davis M/B/24. On November 20, 2024, the victim succumbed to his injuries and was pronounced deceased at 6:43pm. An additional charge of Murder was filed against the suspect in this offense.\*\*\*\*

On November 18, 2024, at approximately 11:19PM, Patrol Officers responded to a shooting in the 1900 Block of Deborah Ct. Upon arrival, Officers located an unresponsive adult victim with an apparent gunshot wound. The victim was transported to an area Hospital in life threatening condition. The suspect in this incident was identified as, Alise Schlaegel F/W/20, and was arrested for Felonious Assault and transported to the Franklin County Jail. The circumstances of this incident are still under investigation.

Due to the severity of the injuries sustained by the victim, the Columbus Police Homicide Unit is investigating this incident.
