Incident Summary:  ***UPDATE – The Franklin County Grand Jury has indicted Larry D Hutson, 49, for for two counts of Murder and one count of Weapons under Disability for causing Lane's death. On October 16, 2023, Hutson was arrested and is currently incarcerated at the Franklin County Jail.***  ***UPDATE An outerproved performed to day Wednesday, March 10th, 2024. ***UPDATE – An autopsy was performed today Wednesday, March 10th, 2021. The autopsy revealed that Lane's death was caused by a gunshot wound.***				
On Tuesday, March 9th, 2021, at 2:15PM, Columbus Police Officers were called to 2117 Winslow Dr. on a report of a deceased female at that location. On arrival, officers found 46-year-old Felecia Lane inside her apartment unresponsive. CFD Engine 15 responded and pronounced Lane deceased at 2:20PM.				
Due to suspicious circumstances at the scene, homicide detectives were summoned and are treating Lane's death as a homicide.
