Incident Summary: ****Update October 4, 2023: Investigators have identified the following suspects for their involvment in the Homicide in the 8300 block of Sancus Blvd. Zackeyis Davis M/B/22 was charged with aggravated murder and Darius Wynn was charged with Murder. Both suspects were arrested and slated in the Delaware County Jail.****

On August 24, 2023, at 5:11 PM, Columbus Police officers were dispatched to the 8300 block of Sancus Blvd. on a reported shooting. Upon arrival, officers found one victim, identified as ALEJANDRO FAJARDO-TORRES, M/H/43, suffering from gunshot wounds. Columbus Fire medics pronounced FAJARDO-TORRES deceased at 5:19 PM. A second victim, identified as ADULT #2, was suffering from a blunt-force trauma injury. Westerville Fire medics transported ADULT #2 to a local hospital in stable condition.

Next of kin notification has been made. At this time, robbery is being considered as a possible motive. The investigation continues.
