**Incident Summary:**  
 \*\*\* UPDATE: The victim has been identified as TYDAY'SHA E. ROBINSON, F/B/19. Next of kin notification has been made. The preliminary investigation indicates a dispute occurred between ROBINSON and STAFFORD regarding their past intimate relationship. \*\*\*

On September 24, 2023, at 10:26 PM, Columbus Police officers were dispatched to the 1600 block of Alona Dr. on an unknown complaint after the caller reported a person was unresponsive. Upon arrival, officers found one victim, identified as ADULT #1, inside the residence and suffering from visible injuries. Clinton Twp. Fire medics transported the victim to a local hospital, where ADULT #1 was pronounced deceased at 11:27 PM. The suspect, LATRELL STAFFORD, M/B/19, was detained at the scene and has been charged with Murder.

A presumptive identification of ADULT #1 has been made and is being withheld until next of kin notification has been made. At this time, the motive is unknown. The investigation continues.
