Incident Summary: *UPDATE 9/8/2024***** On September 8, 2024, despite all efforts by medical staff, the victim in this incident, identified as Mr. Timothy Davis, was pronounced deceased at 12:15 PM. Next of kin have been notified. The suspect, Mr. Ashley, has been charged with one count of Murder.

Detectives would like to renew their request for witnesses or anyone having video of the incident to please come forward.

On September 6, 2024, at approximately 1:53 PM, Columbus Police Patrol officers were dispatched to the 1300 block of North High Street on report of a fight between two men. Upon arrival, officers found the victim suffering from severe head injuries. Officers located a suspect, Mr. Adrian Ashley, nearby and took him into custody without incident.

The victim was transported by CFD Medic 7 personnel to a local hospital in critical condition. Due to the severity of the victim's injuries the Homicide Unit is investigating.

Mr. Ashley was subsequently charged with Felonious Assault regarding this incident.

It is believed several witnesses recorded the assault as it took place. Detectives would like to speak with those individuals regarding what they observed and may have captured on video.
