### Questions and Recommendations from the Civilian Police Review Board

- 2024-0836: Is there a way for something to be placed in the officers file when the officer is the process of leaving CPD in the process of an open investigation so just in case they transfer to an
- Tiara: If the offense is at a certain level of offense the officer leaves/retires in “bad standing.”
- Is there a time limit for the note to be added into an Officers file? They normally ask if there’s an open investigation.
- 2024-0598: Kyle: The choice to tow the vehicle because it was parked too far from the curb; were there other steps that could have been made? Is this a common practice to tow? Why not write a ticket?
- 2024-0876: If the officer is in the middle of giving a jaywalking citation, is the Officer able to chase a suspect if they haven’t witnessed them doing any wrong? The way this report was written it does not appear that the drug transaction is why the complainants were stopped by the officers.
- Is there a “chase” vs “no chase” policy?
- Kyle: Is there “best practices” for jaywalking?
- 24-0876: Were there drugs found on the complainant? Yes, there were. When there are inconsistencies made by the witnesses/Officers how does the Investigator determine what is used and how the report is written to come to a decision on a case?
- **Recommendation to CoC:** The CPRB recommends that the CoC review their chase/no chase policy and discuss the right for a citizen to flee. Motion by Pastor Rich Nathan, 2<sup>nd</sup> by Mary Younger.
