Project: Fantastic Food Garden Mural

Applicants presented the Summer Jam mural project at the January Commission meeting. They explained that they planned to integrate an earlier, smaller mural into the newly proposed mural, which will have a farm to table healthy eating theme. The mural design was favorably received. However the application was tabled until applicants contacted Arron Grover, artist of the first mural, to request his approval to combine his art with the new mural.

Discussion:

Applicants stated that they secured Grover’s approval and an email stating same from Grover to Von Niessen was entered into record. Applicants briefly revisited the proposal design and “farm to table” theme of the 2016 Summer Jam at Westgate Park. Having reviewed the art proposal at their January hearing, Commissioners moved to make a motion to approve the mural art and its placement at Westgate Park.
