- Remove existing fence and concrete in front of parcel.
- Install new "buffwash" paving at the corner of High Street and East Hoster Street, and at parking apron.
- Re-pour existing concrete sidewalk along High Street.
- Install contemporary wood screen/fence with bar top separating outdoor seating areas from High Street.
- Install contemporary style metal "picket-style" fence along the property line and parking lot frontage.
- Install new street-trees in metal grates along High Street frontage in consultation with City of Columbus Public Service Department.
- Install new festoon lighting over patio and up-lighting on trees within landscaping beds.

- All glass to be clear, not tinted.
- Recover existing awning; awning to be "Black" with open ends, with vinyl lettering as shown on drawings.
- Install new, thirty-six inch wide (36" W) wooden hanging sign on existing bracket. <u>Appropriate sign cutsheets to be submitted to the Historic Preservation Office staff for final review and approval prior to installation.</u>

Exterior Painting

 standards.
- Prepare all exterior, wooden surfaces on the main house for repainting using the appropriate hand tools.
- Glaze and caulk as necessary.
- Prime all new and bare wood surfaces with the appropriate exterior primer according to manufacturer's specifications, and per submitted paint color chips.
- Any previously unpainted, masonry (i.e., brick/stone/concrete sills, lintels, porch columns, etc.) is to remain unpainted.
- Any previously painted masonry is to be left as is, or be painted to match the original color of the unpainted masonry as closely as possible.
- Paint color chips for any previously painted masonry are to be submitted to Historic Preservation Office staff for final review and approval, prior to application of paint.
