Additional Information:

- All employees are eligible, regardless if they have the City's health insurance, are full or part time.
- Blood pressure, cholesterol & diabetes screenings are done by finger stick;
- Cholesterol results are adjusted if you ate before your appointment- **fasting is optional.**
- Take all prescribed medications the day of your appointment.
- Results will be given to you at your appointment. Screenings are not performed by City employees.
- Aggregate results are used to guide future programs.
- Employee eligibility for health insurance or insurance contribution rates will not be affected by participation.
- Gift cards are subject to tax

Flu shots are provided at clinics with an (*).

If you were screened earlier in the year, or just want a flu shot, appointments are not needed.
