CONSIGNOR POLICY

CONSIGNORS

- Must be at least 50 years of age and live in Franklin County or adjacent counties.
- Must pay \$40.00 fee per year to sell items in the Golden Hobby Gift Shop. This fee is due February 1 and is not prorated at any time. If dues are not paid by the due date items are pulled and stored for pick up.
- Must have an appointment to enter items into the shop and are allowed one appointment per month unless consignor is a volunteer, then two appointments are allowed. Appointment times are in 30-minute intervals, Tuesday through Friday. For consignors who are employed full time, Saturday appointments are available. Intake ends for the year Wednesday before Thanksgiving.
- Consignors are asked to bring a list of items with the quantity of each category, price the consignor wants and a brief description of the items.





SALES

- Consignors set their own prices – 100% is paid to them when items sell. Golden Hobby Gift Shop adds 20% to the consignor price (netting 17% to the shop for operating costs).
- Payment for items sold the previous month is paid by the 10th of the current month.
- Golden Hobby Gift Shop is not responsible for breakage, theft or wear and tear of items, although we do everything within reason to prevent this.
- Consignors may lower the price of their items by 25% or more once during the year and are responsible for pulling the items from display to be re-tagged. The original intake month is retained.

ITEMS

- All items must be handcrafted, fresh, odor and stain free, and are subject to review/decision as to design, workmanship and quantity. Food items are not accepted. Scented items must be sealed.
- Consignors may have 10 of any kind of item (category) in the shop at any time, i.e., different size, color, material and/or price doesn't affect a category. As items sell, the inventory of a category may be replenished to 10 total once per month. Golden Hobby Shop reserves the right to restrict/refuse items and to determine what makes up a category.
- Anything that hangs should be ready to hang, e.g., wire or cord on pictures and wreaths. Sawtooth hangers don't work with our display devices.
- Business cards, tags or stickers containing contact information are not allowed, i.e., address, phone, email or website. Any consignor-created tag needs to be





size appropriate for the item. It's recommended that pottery and wooden items that could hold food be marked as food-safe.

- With the exception of seasonal/holiday items, all items will be displayed in the shop for one year. At the end of the year, consignors will be notified in writing that they have 60 days to pick up any unsold year-old merchandise and if not picked up or called about in 60 days, the item becomes the property of Golden Hobby Gift Shop.
- Seasonal/holiday items are accepted and pulled per the Schedule of Intake. Unsold items must be picked up or called about within 30 days of notification or the items become the property of Golden Hobby Gift Shop. Unsold December holiday items must be picked up in January – the shop is closed to the public all of January but pick-up dates will be published in the Shop News; no notices are mailed.
- Year-old and seasonal merchandise pick-ups: Consignors may leave 1 large/medium or 2 small items for the 4-Seasons Room. Year-old items must be marked down by 50% or more and are re-tagged for an additional year. Seasonal items retain the original prices and tags.
- If applicable, Golden Hobby Shop consignors acknowledge that they are in compliance and conformance with any and all copyright laws and agreements when selling items that are trademarked, licensed, franchised or copyrighted from entities such as sports teams, businesses, etc., when those products include logos, insignia, indicia, etc., owned and copyrighted by that entity.
