#### **PROPOSED USE:** Type "A" home day care facility. **NORTH EAST AREA COMMISSION RECOMMENDATION:** Disapproval Approval.

**CITY DEPARTMENTS' RECOMMENDATION:** Approval. The requested Council variance will allow a Type "A" home day care facility to operate within an existing single-unit dwelling in the R-3, Residential District. The R-3 Residential District permits only Type "B" home day care facilities, or child day care centers as accessory uses to a church or school. The applicant had originally requested to convert the dwelling into a day care center for 40 children, but after initial recommendations of disapproval were received from Staff, the proposal was revised to the less-intense Type "A' home day care facility. The site is within the planning area of *The Northeast Area Plan (2007)*, which proposes low density residential uses for this location. Since the primary use of the property will still be a single-unit dwelling, Staff has no objection to the requested Type "A" home day care use which must comply with Ohio Revised Code requirements and be inspected by the Ohio Department of Job and Family Services.

To grant a Variance from the provisions of Sections 3332.035, R-3, Residential District; and 3312.49, Minimum numbers of parking spaces required; of the Columbus City codes, for the property located at **2363 EHRING ROAD (43211)**, to permit Type "A" home day care facility for a maximum of 12 children within an

existing single-unit dwelling with reduced parking in the R-3, Residential District (Council Variance # CV11-031).

WHEREAS, by application #CV11-031, the owner of the property at 2363 EHRING ROAD (43211), is requesting a Variance to permit a Type "A" home day care facility to operate within an existing single-unit dwelling in the R-3, Residential District; and

**WHEREAS**, Section 3332.035, R-3 Residential District, permits only Type "B" home day care facilities, or child day care centers as accessory uses to a church or school, while the applicant proposes to operate a Type "A" home day care facility for a maximum of 12 children within an existing single-unit dwelling in the R-3, Residential District; and

**WHEREAS,** Section 3312.49, Minimum number of parking spaces required, requires one (1) parking spaces per five hundred (500) square feet of day care facility space, while the applicant proposes zero (0) parking spaces for the Type "A" home day care facility, and instead requests that the existing driveway serving the detached garage be used for parking when needed; and

**WHEREAS**, this variance will allow a Type "A" home day care facility to operate within an existing single-unit dwelling in the R-3, Residential District; and

**WHEREAS**, the North East Area Commission recommends disapproval of the original day care centerproposal for 40 children, but did not consider the Type "A" home day care proposal; and

**WHEREAS**, City Departments recommend approval because the primary use of the property will still be a single-unit dwelling, and Staff has no objection to the requested Type "A" home day care use which must comply with Ohio Revised Code requirements, and be inspected by the Ohio Department of Job and Family Services; and

**WHEREAS**, said ordinance requires separate submission for all applicable permits and Certificate of Occupancy for the proposed use; and

WHEREAS, said variance will not adversely affect the surrounding property or surrounding neighborhood; and

This project consists of maintenance and repair of various components of street lighting circuits 27, 30, 35, 43, 72, 80, 119, and 127. The project includes replacement of overhead and underground conductors with associated materials, including but not limited to, lights, wire racks, spools, conductors, pins, fuse kits, and all other materials necessary to restore street lighting circuits to meet City of Columbus most current specifications. The existing components on these circuits are old and deteriorated. Due to the age of the system, there are frequent light outages. The Division of Refuse Collection utilizes Automated Side Loader Refuse Trucks in city-wide residential trash pick-up. The Department of Public Service and Fleet Management recognize the need to replace older trucks in its fleet beyond the useful service life of the vehicle. The City will establish a one-time contract for the purchase of 18 Automated Side Loader Refuse Trucks with the Compressed Natural Gas (CNG) Option. The terms of the proposed contracts are from the date of execution by the City up to and including the manufacturer's build out date. The Purchase Office opened formal bids on March 8, 2012.

The Purchasing Office advertised and solicited competitive bids in accordance with Section 329.06 (Solicitation SA004283).

Bid specifications included options for diesel engines, compressed natural gas (CNG) engines, and Webasto Heaters. One hundred and four (104) vendors were notified of this solicitation (MIA-1, MBR-2 and MBR-1); three (3) majority bids were received.

The Department of Public Service recommends award of the contract to the lowest, responsible and best bidder:

This expense is budgeted within the 2012 Capital Improvement Budget. This expense can be accommodated by utilizing available funds in the amount of \$4,852,774.06 within the Refuse G.O. Bonds fund and the Build America Bonds Fund Partial Funding for this expenditure is available within the Refuse G.O. Bonds Fund and Build America Bonds Fund and by appropriating the remaining funds needed, \$436,257.94 within the Special Income Tax Fund and transferring those funds to the Refuse G.O. Bonds Fund. As the current vendor was awarded the original contract through competitive bidding and now has unique knowledge of DPU's needs for AVL services, it is not in the City's best interests to procure additional services through an alternate procurement method. Wireless Matrix will continue to honor the pricing agreed to in the original agreement.

The AVL system enables the location and monitoring of City-owned vehicles, and has been deployed on 532 DPU vehicles. The system is used to determine the geographic location of vehicles through the use of a GPS and transmits the location back to the requestor. The system visually displays the location of the vehicles in near real time, as well as records the information for replay and reporting.

The benefits of the system include:

<u>Crosswalk Design</u>. The consultant will produce construction drawings for crosswalk improvement projects. These drawings will be for multiple locations for spot improvements. Examples of work may include but are not limited to raised crosswalks, curb ramps, sidewalk, curb extensions, pedestrian refuge islands, street lighting, basic and hybrid signal design, pavement marking and signing and drainage improvements.

#### **1. BACKGROUND:**

This legislation authorizes the Director of Public Service to enter into a professional engineering services contract with Glaus, Pyle, Schomer, Burns & Dehaven, Inc. (GPD Group), for the Bridge and Trail Improvements - West Fifth Avenue from McKinley Avenue to Dublin Road project.

This project involves preliminary and final engineering for a wider Fifth Avenue bridge over the Scioto River and an extension of the Scioto Trail between Dublin Road and McKinley Avenue. The specific scope of work for Part 2 will be developed upon completion of Part 1 and will generally consist of final engineering, environmental clearance, and construction plan production.

16 ADA ramps will be added or reconstructed in this project. There are 6 bus stops and transit routes within the limits of this project. This project complies with the recommendation of the Pedestrian Thoroughfare Plan because the project will utilize the PTP for guidance in determining improvements. Pedestrian generators and destinations impacting the proposed project include large multi-family residential apartment complexes (Runaway Bay and the Quarry) and several office buildings.

Design costs, including both parts described above, are estimated to be \$650K of which \$203,915.97 is requested for Part 1. This contract will determine costs for construction, acquisition, utility reimbursement, and inspection.

The Department of Public Service, Office of Support Services solicited Requests for Proposals for the Bridge and Trail Improvements - West Fifth Avenue from McKinley Avenue to Dublin Road contract. The project was formally advertised on the Vendor Services web site from December 22, 2011, to January 26, 2012. The city received six (6) responses. A proposal from Jones-Stuckey, Ltd. was deemed non-responsive due to their not meeting all required ODOT pre-qualification categories.

The remaining proposals were deemed responsive and were fully evaluated when the Evaluation Committee met on February 13, 2012.

In 2011, Columbus Public Health was awarded a grant from the Ohio Department of Health in the amount of \$125,000.00 for the Dental Sealant grant program for the period of January 1, 2011 through December 31, 2011. There was a delay in the grant budget being approved, which therefore pushed back the hiring process. Due to this delay, not all of the grant monies could be spent. The purpose of this ordinance is to authorize a refund of unused grant funds and interest income in an amount not to exceed \$6,818.23 to the Ohio

Department of Health.

The primary objective of the Dental Sealant grant program is to prevent dental caries among school children through an evidence-based community approach. **Background**: This ordinance authorizes the Finance and Management Director to issue blanket purchase orders for various automotive equipment, parts, supplies, and various services for the Fleet Management Division. Services also provided include the Fleet Focus Management System and the CNG fueling stations. The vendors in this ordinance are designated as sole source.

The sole source vendors listed herein are 1) local makers and distributors of vehicle equipment and parts, 2) the local authorized dealers for manufacturer's parts, or 3) the only authorized facility to perform manufacturer or warranty repairs within a geographic area (City of Columbus, Franklin County).

**BACKGROUND:** The Board of Health received funds for the Sexually Transmitted Disease (STD) Prevention grant program from the Ohio Department of Health. The STD Prevention program enables Columbus Public Health to identify and prevent sexually transmitted diseases through gonorrhea culture screening, syphilis elimination, gonococcal isolate surveillance, and partner services. Additionally, Columbus Public Health assures the quality of medical and laboratory services, surveillance, partner services, and data management. All activities are conducted with special emphasis on populations at high risk. The Board of Health will contract with The Research Institute at Nationwide Children's Hospital to provide community education and training for syphilis elimination.

This contract was advertised on Vendor Services in April, 2012, in accordance with the City's competitive bidding requirements (SA004336). One proposal was received and The Research Institute at Nationwide Children's Hospital was awarded a contract. The vendor is a nonprofit organization and is therefore exempt from contract compliance.

Emergency Action is required to ensure the continued operation of the STD Prevention grant program.

**Background:** This ordinance authorizes and directs the Director of the Department of Development to authorize the assignment and assumption of developer responsibilities under a Clean Ohio Revitalization Fund (CORF) agreement, authorized under Columbus City Council Ordinance 0918-10, approved June 28, 2010, for the residential development project at the former Kimball-Midwest site on 580-582 West Goodale Blvd.

Ordinance 0918-10 authorized the Director to enter into an agreement with Wagenbrenner Development, Inc. to apply an awarded \$3 million CORF grant to environmentally remediate the site and invest approximately \$9 million to construct 90-120 market rate apartment units. The agreement allowed for an assignment and assumption option if and when Wagenbrenner determined it wanted to sell the property.

Wagenbrenner recently completed environmental remediation at the former Kimball-Midwest site and the property is now ready for vertical construction. Wagenbrenner however wishes to exercise its option to sell the property to another Columbus area developer, Kaufman LLC, and has requested the Director of Development to authorize the assignment and assumption of responsibilities to develop the site.

Kaufman wishes to invest approximately \$20 million to construct a five story mid-rise apartment complex with 175 units and a parking garage. The project is approved, permitted and can be complete by the fall/winter of 2013, if the requested assignment and assumption is approved by Columbus City Council.

This ordinance is submitted as an emergency to effect assignment and assumption by Wagenbrenner to Kaufman as soon as possible so that construction may commence.

Fiscal Impact: There are no costs to the City of Columbus under this ordinance.

**FISCAL IMPACT**: The statement of municipal services and zoning conditions for a proposed annexation area has no fiscal impact. While provision of the stated services does represent cost to the city, annexation of land also has the potential to create revenue to the city.

To set forth a statement of municipal services and zoning conditions to be provided to the area contained in a proposed annexation (AN12-006) of  $4.907 \pm$  acres in Perry Township to the City of Columbus as required by the Ohio Revised Code; and to declare an emergency.

WHEREAS, a petition for the annexation of certain territory in Perry Township was duly filed on behalf of the Billingsley Properties LLC, et al. on May 23, 2012; and

WHEREAS, a hearing on said petition is scheduled before the Board of County Commissioners of Franklin County on June 26, 2012; and

**Public Safety:** The City of Columbus, Department of Public Safety will be able to provide the appropriate level of safety related services to the proposed annexation area. Such services will include police and fire protection as well as emergency medical service to the subject property.

While the petitioner for annexation may have proposed future development plans for the property in question, the Department of Public Safety requests that the City exercise its discretion in the coming development planning and review process to ensure any future development will be properly served by the Department of Public Safety. If this annexation contains existing signalized intersections, those intersections and signals are subject to Transportation Division Policy, which appeared in the December 6, 2003 Columbus City Bulletin, and any subsequent updates thereto.

Water: The site will be served by an existing 12" water main in located in Billingsley Road.

**Sanitary Sewer:** Records indicate this property can be served by an existing 12-inch sanitary sewer situated within an easement along the south side of Billingsley Road through the property proposed to be annexed. Any mainline extension is to be designed and constructed at the property owner's expense.

**Storm Sewer:** All storm sewers necessary for development/redevelopment of the area shall be designed in accordance with design policy and zoning codes in effect at the time of development. All sanitary and storm sewers required shall be constructed privately by the owners and developers at their own cost and expense with no cost to the City.
