Background: The Mid-Ohio Regional Planning Commission (MORPC) received a grant from the Ohio Lake Erie Commission in late 2009, which was augmented with transportation funding, to undertake balanced growth planning in Central Ohio. During 2011 and 2012, MORPC worked with communities in the Big Walnut and Upper Scioto watersheds to prepare balanced growth plans for each of these areas. Columbus representatives attended project meetings and provided input on map and text portions of the documents. resulting plans identify priority areas for agriculture, conservation, and development. The plans also outline tools and programs to protect and enhance Priority Agriculture and Conservation Areas while focusing sustainable development in Priority Development Areas. The consultant will provide database administration and system administration duties, and facilitate performance tracking and reporting. BACKGROUND:

The College Park Apartments, a complex of 250 units located at 1669 College Avenue, has elected to transfer its electric service whose tenant spaces are individually metered by the City of Columbus, Department of Public Utilities (City) to a master meter arrangement with Nationwide Energy Partners, LLC (NEP). To efficiently implement College Park's request, the City seeks approval to enter into an agreement with NEP to transfer City-owned equipment following the requested conversion to a master meter arrangement. The agreement between the parties includes, but is not limited to, the following key provisions:

- 1. NEP will convey one 2000' spool of #1 3C CU 15KV cable shielded TRXLPE jacketed with #2 ground (DOPW-P Stock Code 50396) to the City in exchange for the approximately 6000' of existing single primary cables installed on the property.
- 2. NEP will pay via check the amount of \$28,175.00 for the thirty post-top lights on the property. NEP determined the current value of the post-top lights based on a straight-line depreciation of the useful life of these assets.
- 3. NEP will energize the new primary feed onto College Park from the overhead AEP primary meter located at the entrance of the property. NEP anticipates feeding this with one phase. Although College Park currently has radial feeds, NEP will have loops built prior to the turnover.
- 4. While maintaining the City feed, NEP will decommission three to five transformers per day, remove them from the pad and install new transformers in their place. At this time, the residential meters supplied by these transformers will be exchanged with NEP's meters. NEP will remove the City meters and collect final reads for the City. NEP estimates it will complete the entire project five working days.
- 5. With regard to the lighting, NEP will cut the lighting circuit from the City line outside the property and install a new transformer, sub-meter and control box.
- 6. Upon completion of the transfer, NEP will deliver the removed transformers and residential meters to the City's Division of Power & Water Indianola Avenue facility.

The Department of Public Utilities requests approval to implement the above described process. The estimated value of this remuneration including returned equipment is one third the estimated initial cost of the system. Because this asset transfer is not in compliance with City Code procedures concerning equipment disposal, waiver of City Code is required to allow appropriate paperwork to be completed at the time of the equipment transfer.

Emergency legislation is being requested because NEP and College Park Apartments have requested this transfer occur as quickly as possible, to avoid the removal of City assets during the winter months.

FISCAL IMPACT:

There is no budgetary impact because we are being reimbursed for city facilities. Revenues are not significantly impacted by this legislation.

To authorize and direct the Finance & Management Director to execute an agreement to transfer and sell the City's assets associated with the electric distribution service system located at the College Park Apartment complex to Nationwide Energy Partners, LLC (NEP), to waive the provisions of City Code relating to the sale

of City-owned personal property, and to declare an emergency.

WHEREAS, the Department of Public Utilities, Division of Power and Water installed electric distribution, underground lighting and electric services on private property in the College Park apartment complex in 1999 to 2000; and

WHEREAS, College Park has elected to transfer its electric service to a master meter arrangement with Nationwide Energy Partners, LLC (NEP) and NEP has made an acceptable offer to reimburse the City, to deliver new cable and to return equipment to our facilities while avoiding loss of electrical services to College Park residents, making this transfer in the best interest of the City; and

WHEREAS, after analyzing the existing infrastructure at College Park, it is recommended that to facilitate the transfer of these services to NEP, the City transfer its underground distribution system and light poles and circuits to NEP, and execute the proposal by NEP for NEP to reimburse the City for the depreciated cost of the City's light poles (\$28,175), to reimburse the City for its underground system in the form of new cable delivered to our Indianola location, to remove our transformers and meters and to deliver them to our Indianola facility thereby ensuring the City will receive remuneration for its assets in the form of dollars, new cable and returned equipment with little City labor involved; and

Three training sessions will be held with approximately 60 employees from the Department of Public Service participating.

BACKGROUND: This ordinance approves the acceptance of certain territory (AN12-007) by the City and authorizes its transfer from Plain Township to Montgomery Township per an annexation agreement between the City of Columbus and Plain Township. The Ohio Revised Code stipulates that for an annexation to be effective, City acceptance must take place a minimum of 60 days (but not more than 180) from the receipt by the City Clerk of the approval notice from the county. Should City Council not take such action within this timeframe, the annexation will not take place. This petition was filed with Franklin County on May 21, 2012. Franklin County approved the annexation on June 5, 2012 and the City Clerk received notice on June 13, 2012. No service ordinance was required because this annexation was filed as a Type 1 application as defined by the Ohio Revised Code. Although not required, a service statement reflecting the City's ability to provide services for this site upon annexation is attached.

The use of Type 1 annexations applications is stipulated in the annexation agreement between the City and Plain Township. The annexation agreement also requires that territory annexed to the City of Columbus from Plain Township be transferred to Montgomery Township. Therefore, this ordinance authorizes the submission of a petition to the Board of County Commissioners of Franklin County, Ohio, requesting that the boundary lines of Montgomery County be changed to make them identical with the corporate limits of the City of Columbus for this annexation. The petition will be filed in accordance with Section 503.07 of the Ohio Revised Code. The subject site is also located within the City's Northeast Pay-As-We-Grow (PAWG) area and if developed will be subject to PWAG funding mechanisms applicable to the area including perunit contributions, participation in a Community Development Authority and inclusion in a Tax Increment Financing district.

FISCAL IMPACT: Provision of municipal services does represent cost to the City; however, the annexation of land also has the potential to create revenue to the City.

To accept the application (AN12-007) of Mary A. Adkins and Michael W. Adkins for the annexation of certain territory containing $2.8 \pm$ acres in Plain Township and to authorize the submission of a petition to the Board of Commissioners of Franklin County, Ohio, requesting a change in the boundary lines of Montgomery Township so as to make the boundary lines of this annexation identical with the corporate boundaries of the City of Columbus.

The garden will also provide a safe drop-off point for school and group tours and will be the sole ADA accessible entrance to the Museum during construction involving the 1970's addition and the new wing. The site will be free and accessible to the general public.

The Contract Compliance Number for the Columbus Museum of Art is #31-4379447.

Emergency action is necessary to allow the Columbus Museum of Art to complete additional work as the project has already begun.

FISCAL IMPACT:

The expenditure of \$50,000.00 is budgeted in the Recreation and Parks Voted Recreation and Parks Bond Fund

The City of Columbus, Department of Public Service, received a request from The Kroger Company asking that the City sell a 0.27 acre portion of the Chesapeake Avenue right-of-way west of Northwest Boulevard. Transfer of this right-of-way will facilitate the expansion of an existing store located on property adjacent to the above noted right-of-way. Per current practice, comments were solicited from interested parties, including City agencies, private utilities and the applicable area commission, before it was determined that, subject to the retention of a general utility easement for those utilities currently located within this right-of-way, the City will not be adversely affected by the transfer of this right-of-way. Then Department of Public Service submitted a request to the Department of Law, Real Estate Division, asking that they establish a value for this right-of-way. A value of \$34,705.00 was established for this right-of-way. A request for mitigation was submitted by The Kroger Company and after review of the request and based upon meeting a number of mitigating circumstances, the Land Review Commission voted to recommend a reduction in the established value, and the above referenced right-of-way be transferred to The Kroger Company for \$18,271.00.

2. FISCAL IMPACT:

The City will receive a total of \$18,271.00 that will be deposited in Fund 748, Project 537650 as consideration for the transfer of the requested right-of-way.

1. BACKGROUND

The Department of Public Service employs personnel that are engaged in traffic sign and signal installation, permanent pavement marking application, and roadway improvement design and construction. Project costs incurred by the operating fund are salaries, overhead, overtime, materials and other direct costs. These personnel and project expenses are budgeted within and paid from the division's operating fund, the Street Construction, Maintenance and Repair Fund. These costs can be capitalized. Doing so is consistent with earlier efforts by the Division to reimburse its operating fund when the operating fund incurred expenses more appropriate to capital improvement funding.

This ordinance authorizes the expenditure of \$772,501.53 or so much thereof as may be necessary for this purpose.

2. FISCAL IMPACT

Funding for this expenditure is budgeted and available within the Streets and Highways G.O. Bond Fund, no. 704. The 2012 revenue estimate for the Street Construction, Maintenance and Repair Fund reflects and assumes this revenue. C.I.B. amendments and funds transfers are necessary to move monies and authority to the appropriate projects.

3. EMERGENCY DESIGNATION

Emergency action is requested to allow the reimbursement of these operating expenses at the earliest possible time to make the Street Construction Maintenance Repair Fund whole.

The purpose of this Project is to use a holistic approach to help families who are not well connected to health and social services, and are living in crisis mode. CPH will be relying on help from various social service agencies to assist with this initiative.

In April 2012, Community Development for All People, a not-for-profit agency, launched a new, innovative health and wellness initiative called Healthy Eating and Living (HEAL). The purpose of HEAL is to accompany low and moderate income persons as they set health goals and establish action plans to achieve improved health outcomes for themselves and members of their households. This venture has been designed and implemented in collaboration with other partners that include Nationwide Children's Hospital (NCH), United Way, Mid-Ohio Food Bank, The Ohio State University, and Mt. The Division of Planning and Operations is responsible for street cleaning in Columbus. Debris gathered as a result of street cleaning, brush clearing and other street maintenance activities is dumped at the landfill operated by the Solid Waste Authority of Central Ohio (SWACO). This legislation authorizes the expenditure of up to \$87,500.00 for tipping fees at SWACO's landfill.

2. BID WAIVER

This legislation also waives the formal competitive bidding requirements of the Columbus City Code. Even though refuse disposal services are available in the market place other than those offered by SWACO, competitive bidding must be waived because of the City's contractual relationship with SWACO. Fees are determined based on SWACO's rate setting process in which the City of Columbus has participated, based upon its membership on the SWACO Board.

3. FISCAL IMPACT

Monies are available in the Division of Planning and Operations 2012 Street Construction, Maintenance and Repair Fund appropriation for this expenditure. Tipping fee expenses were \$150,000.00 and \$320,000.00 in 2010 and 2011, respectively. In 2012, The Division of Planning and Operations has spent the initial encumbrance of \$150,000.00. An additional encumbrance of \$20,000.00 has been created and The Division anticipates it will expend the remaining appropriation of \$87,500.00 in 2012 on additional tipping fees for the remainder of the year. Total tipping fee expenses for street cleaning activities in 2012 is anticipated to be over \$250,000.00.

4. EMERGENCY DESIGNATION

Emergency action is necessary to ensure that funds are available and there is no lapse in service or late fee assessed.

The Central Ohio Area Agency on Aging of the Recreation and Parks Department was awarded federal and state grants from the Ohio Department of Aging for the continuation of services to older adults in the Central Ohio area including Delaware, Fairfield, Fayette, Franklin, Licking, Madison, Pickaway and Union Counties. The Mid-Ohio Regional Planning Commission (MORPC) will be accepting Transportation Improvement Program (TIP) applications through August 31, 2012. This is an opportunity for the City to secure outside funding for various roadway improvement projects. MORPC has up to \$50 million to distribute to all applicants for new projects from 2014 through 2019.

The current round of applications will be establishing the 2014-2019 TIP, as well as its long-range project listing for 2020 through 2023. The Transportation Improvement Program is composed of these component sub-programs: The Surface Transportation Program (STP); the Transportation Enhancement Program (TE) and the Congestion Mitigation & Air Quality Program (CMAQ). In addition to funding applications for projects not previously submitted, under its new rules MORPC requests the City "reauthorize" projects submitted prior to 2012 to reaffirm the City's continuing commitment to those projects.

1. BACKGROUND: This legislation authorizes the Director of Public Utilities to enter into a construction contract with Kalkreuth Roofing and Sheet Metal Inc.in the amount of \$73,025.00, for the HCWP Roof Restoration project, Division of Power and Water Contract Number 1178.

This project will furnish all materials, equipment, and labor necessary to provide for the removal of ballast and epdm membrane roof and installation of high performance roof system on the Sodium Hydroxide Building at the Hap Cremean Water Treatment Plant. The HCWP Roof Restoration project will be performed in several phases with separate contracts. Phase I was completed in 2011, the current project is the second phase. A final project will complete the roof restoration on remaining portions of the pump and filter buildings and is scheduled for 2013. 2. ECONOMIC IMPACT/ADVANTAGES; COMMUNITY OUTREACH; PROJECT DEVELOPMENT; ENVIRONMENTAL FACTORS/ADVANTAGES OF PROJECT:

This project is necessary to repair the roof at Hap Cremean Water Plant (HCWP) which was damaged during the wind storm in June 2012. This construction project will stop the water leakage into the area to be utilized as the Sodium Hydroxide Building as part of the Treatment Improvements (Ozone) project currently under construction at Hap Cremean Water Plant. The roof restoration will preserve the integrity of the existing building allowing it to be utilized to house the Sodium Hydroxide treatment process. The HCWP is an essential and integral component in the Columbus area water supply and treatment infrastructure. Adequate supply of water is essential to economic growth and development.

There were no public meetings held regarding this work. The HCWP is a secure facility and is not a publically accessible building.

The project specifications require that the roofing project utilize a modified bitumen membrane incorporating a combination of 28% post industrial and 11% pre consumer recycled content. The roofing surface is specified to be supplied as a white, elastomeric, urethane coating with an Energy Star approval rating.

1. BACKGROUND

This legislation authorizes the Director of Public Service to modify and increase the construction contract with G&G Cement Contractors for the Pedestrian Safety Improvements - Sidewalk Program project in an amount up to \$102,700.73 and to provide for additional construction administration an inspection services in the amount of \$14,299.27.

Work performed to date as part of this contract consists of on-call tree root related sidewalk and curb ramp construction. Work also consists of crosswalk improvements and installation of medians, pavement markings and basic traffic signal equipment.

Work to be performed as part of this contract modification includes but is not limited to the construction of 170 linear feet of sidewalk and a single drive approach on Fairwood Avenue between Whittier St. and Reinhard Ave. The balance of the modification will increase the number of locations where sidewalks can be replaced due to damage from city street trees and other work as necessary.

This work was added to this contract as the best contract to enable construction this year and had the most similar type of work and pay items. Additional funds were also added to the contract in order to address the backlog of sidewalk damage locations due to city street trees.

The cost of the modification is small and would not be cost effective to utilize a formal bidding process. Additionally bidding this as a separate contract would jeopardize completion by the end of this year. The construction of these sidewalks alleviates safety issues to sidewalks damaged by tree roots.

The Board of Health has contracted with AIDS Resource Center Ohio and Lancaster Fairfield Community Action Agency to provide these services. The project limits are Hard Road from Sawmill Road to 387 feet west of Smoky Row Road. The length of the project is approximately 1.2 miles. BACKGROUND:

This legislation authorizes the Finance and Management Director to establish purchase orders for furniture and technology infrastructure; authorizes a contract for building signage; modifies a contract for the coordination of the delivery and placement of said furniture and signage; and establishes an Auditor's Certificate for a building contingency for any items that may been overlooked for the nearly 225 employees of six city agencies and/or departments that will move into the newly renovated facility at 120 West Gay Street, commonly known as the Old Central Police Building. Employees from the following six agencies will move into this facility:

- o City Attorney's Office (from City Hall and 109 N Front),
- o Civil Service (from Beacon not Piedmont),
- o Income Tax (from Beacon),
- o Public Safety Director Office (from Beacon),
- o Purchasing (from Beacon), and
- o Human Resources Department (from City Hall).

Specifically, this legislation authorizes the Finance and Management Director to establish purchase orders with King Business Interiors, OfficeMax Incorporated d/b/a OM Workspace, O'Reilly Office, LLC, and Pomeroy IT Solutions from existing or pending UTCs for the purchase of furniture, technology infrastructure, fixtures, and equipment.

This legislation also authorizes the Finance and Management Director to establish a contract with Identitek Systems, Inc. d/b/a Adam Signs for interior building signage. The Purchasing Office solicited formal bids through SA004511 and three companies submitted bids. Identitek Systems, Inc. d/b/a Adam Signs is the lowest, responsive, and responsible bidder.

Furthermore, this legislation authorizes the Finance and Management Director to modify a contract with Messer Construction Company. The original Messer contract was authorized by Ordinance No. 0830-2011, passed June 8, 2011, and subsequently modified by Ordinance No. 1750-2012, which passed July 30, 2012. The initial contract authorized the renovation of the 120 West Gay Street Building. The first modification of the contract was required due to unforeseen issues identified during the renovation project. The purpose of this latest modification is to enable Messer to oversee the acceptance and coordination of furniture, fixtures, equipment, and signage to the facility. By bidding these items separately the City has achieved cost savings over the more traditional city method of purchasing furniture, fixtures and equipment as the contractor's responsibility; however, it is still logical to have the contractor (Messer) involved by coordinating the placement and delivery of the materials while the project is nearing completion and, if in the delivery process, damage were to occur.

Finally, this ordinance establishes an Auditor's Certificate of \$63,616.00 as a building contingency. Despite the very best of planning, a move of this magnitude and complexity is likely to have overlooked something so a building contingency is to be established.

Emergency action is requested to ensure the necessary services are available when the construction of the offices is complete and areas are ready for occupancy - currently expected to be late December or early

January 2013.

Fiscal Impact: The 2012 CIB established a \$2,000,000.00 line item for these expenditures.

Background: In April, 2009 the Department of Finance and Management, Real Estate Management Office solicited Request for Proposals (RFP) No. SA003242 to identify qualified insurance brokers, insurance agencies, or insurance agents to provide insurance brokerage and risk engineering services for the City's three (3) insurance programs - property (casualty), boiler and machinery, and aviation. Based upon the evaluation of the bid responses, the City entered into an agreement with Arthur J. Gallagher Risk Management Services, Inc. for insurance brokerage and risk engineering services pursuant to Ordinance No. 0943-2009. The contract contained an initial one-year term and four one-year automatic renewals subject to appropriation of funding by City Council and certification of funds availability by the City Auditor. The contract is currently in its third renewal term as authorized by Ordinance No.1348-2012.

Since 2009, City operations have been expanded to include new services to the public that were not provided when the contract for insurance brokerage and risk engineering services was initiated. In order to best protect the interests of the City and to provide for prudent management of risk, it has been determined that a fourth program of insurance for commercial general liability should be added to the City's insurance coverage. The existing contract with Arthur Gallagher does not include requirements for the provision of this type of coverage. Therefore, in order for the City to obtain brokerage services for commercial general liability coverage, the current contract with Arthur J. Gallagher Risk Management Services, Inc. must be amended to include the City's requirements for the provision of services associated with this fourth program of insurance.

The Contract Compliance Number for Arthur J. Gallagher Risk Management Services, Inc. is 36-2102482 and the expiration date is 01/12/2014.

Fiscal Impact: The final cost of the commercial general liability coverage is not available until the broker completes the solicitation of quotes from various underwriters in the market. The estimated annual cost of this coverage is approximately \$30,000. Funds for the City's 2012-2013 insurance programs were previously appropriated via Ordinance No.1348-2012 and are available on AC 033841 to cover the cost of this new coverage.

BACKGROUND: This legislation authorizes the Director of the Department of Development to enter into an agreement with The Father's House International, Inc (an Ohio nonprofit 501(c) 3) to assist with the rehabilitation of an emergency shelter facility serving homeless individuals or families. CSB will lease the building from the current owner The Father's House International, Inc. The current phase of the project includes general trades, mechanical and electrical in order to bring the building to code for habitation. Additional phases of build out are expected to be requested in future years.

Emergency action is requested for this legislation in order to comply with the time line for the projects to begin construction.

FISCAL IMPACT: Funds for this project are included in the 2012 Capital Improvements Budget.


