This resolution declares the City of Columbus' support for the My Brother's Keeper (MBK) Task Force's Youth Perspective Report & Next Step Recommendations.

On February 27, 2014, President Barack Obama launched My Brother's Keeper to expand opportunities for boys and men of color. In September 2014, President Obama issued a national challenge to cities, townships, tribes and counties to create and implement "cradle-to-college-and career strategies" to address two of the six following challenges:

- · Ensure that children enter school cognitively, physically, socially and emotionally ready;
- Ensure children read at grade level by the third grade;
- · Ensure youth graduate from high school;
- Ensure youth complete post-secondary education or training;
- Ensure youth out of school are employed; and/or
- · Ensure youth remain safe from violent crime.

On December 1, 2014, the Mayor hosted its first MBK Community Forum, attending by nearly 400 community stakeholders. In May 2015, the Mayor and City Council formed the MBK Task Force to focus on workforce development, and community violence and safety. Four youth summits were hosted at Linden-McKinley STEM 7-12 High School, West High School, South High School, and Walnut Ridge High School to gather information on the needs of the City's boys and young men of color.

The resulting recommendations are:

- The City should appoint a key person in the Mayor's Office to lead and oversee the City's My Brother's Keeper efforts;
- The City should promote the need to enhance the capacity of HandsOn Central Ohio, Columbus' 2-1-1 centralized information and referral system, so that it can serve as the city's one-stop shop that connects residents with the existing programs and service they need, when they need them;
- The City should convene service providers working in the following spaces to identify and implement ways they can better work together to support the success of African American male youth and other:

 (a) education; (b) personal development, health and self-governance; and/or (c) relationships and community;
- The City should proactively include the youth voice in policy and decision-making, as well as program and event development and implementation;
- The City should use data to establish short- and long-term goals to measure the success of African American male youth.

To endorse and support the My Brother's Keeper Initiative's Youth Perspective Report and Next Step Recommendations.

WHEREAS, the City of Columbus accepted President Barack Obama's challenge to explore closing the opportunity gap and expanding opportunities for boys and young men of color through the My Brother's Keeper initiative; and

WHEREAS, the My Brother's Keeper Task Force has studied the issues of workforce development, and community violence and safety as barriers to happy, health and productive lives for Columbus' boys and young men of color; and

The existing sandstone porch in front of the Health Department Building located at 240 Parsons Avenue is currently shored up because it has begun to deteriorate due to its age. The project scope will also include window and roof repairs at the North Dorm to stop water infiltration. It is necessary to replace the failing steel support lintels above the window openings along with the affected brick facade.

The Department of Finance and Management, Office of Construction Management solicited bids for the Columbus Public Health Porch & Exterior Improvements Project. The project was formally advertised on Vendor Services from July 14, 2015, to August 6, 2015. The city received two (2) bids. After alternates were chosen, the final bid amounts are:

Lincoln Construction, Inc. \$1,261,964.00 2K General Company \$1,292,004.00

The City advertised the project on Vendor Services and received two bids. Both bids had errors, resulting in the Director of the Department of Finance and Management requesting a waiver of Columbus City Code Chapter 329 for the selection of construction services for this project.

The lowest bidder is Lincoln Construction, Inc. City Code, Chapter 329.20(h)(1) states that bidders shall, "Provide a list with its bid submission of all subcontractors the bidder intends to utilize for the project..." Lincoln Construction stated in their bid that they would perform all the work and not employ any subcontractors. During the bid evaluation process, Lincoln Construction indicated that they will be subcontracting about 44% of the work.

2K General Company included a list of subcontractors in their bid, however, they did not list one of the three approved masonry subcontractors included in the Invitation for Bid (IFB). Due to the complexity of the masonry work on the project, the city stated in the IFB that one of the approved subcontractors must be used on the project. Instead, they listed a subcontractor not on the list. Additionally, they did not request that the company they listed be added to the approved list while the project was advertised. Since the city did not have an opportunity to evaluate 2K General's masonry subcontractor and possibly add them to the list, other bidders did not have the opportunity to possibly consider this additional subcontractor.

All other portions of Lincoln Construction, Inc.'s bid conformed to the requirements of Chapter 329 of Columbus City Code except their listing of subcontractors, therefore, competitive bidding must be waived.

Emergency action is requested in order to expedite remediating these existing safety concerns as identified above.

1. BACKGROUND

The Department of Public Service is responsible for routine and emergency maintenance and rehabilitation of the roadway system, snow and ice removal and control operations, the installation and maintenance of roadway signage and lighting, and refuse collection. To meet these responsibilities, the Department of Public Service employs an extensive and varied fleet of vehicles. In order to maximize utility of the fleet, it is necessary that a portion of these vehicles be equipped with voice radios. This enables greater coordination of fleet units by enhancing the ability of supervisors to dispatch vehicles to needed locations at a moment's notice. The department utilizes an 800 MHz radio system owned and operated by Franklin County and coordinated by the Central Ohio Communication Advisory Committee for voice transmissions.

This legislation authorizes the Director of Public Service to modify an agreement with Franklin County to extend the contract through and including June 30th, 2016; and increase the contract total amount not to exceed \$177,264.00. BACKGROUND: This legislation authorizes the Finance and Management Director to modify a contract on behalf of the Office of Construction Management with 2K General Company for the Apparatus Bay Slab Remediation project for the Division of Fire.

BACKGROUND: This ordinance approves the acceptance of certain territory (AN15-013) by the City of Columbus and authorizes its transfer from Plain Township to Montgomery Township per an annexation agreement between the City and Plain Township. The Ohio Revised Code (ORC) stipulates that to be effective, City acceptance must take place a minimum of 60 days (but not more than 180) from the receipt by the City Clerk of the approval notice from the county. Should City Council not take such action within this timeframe, the annexation will not take place. This petition was filed with Franklin County on June 26, 2015. The Board of Commissioners approved the annexation on July 14, 2015 and the City Clerk received notice on July 27, 2015. No service ordinance was required because this annexation was filed as a Type 1 application as defined by the ORC. Although not required, a service statement reflecting the City's ability to provide services for this

site upon annexation is attached.

The use of a Type 1 annexation application is stipulated in the annexation agreement between the City and Plain Township. The annexation agreement also requires that territory annexed to the City from Plain Township be transferred to Montgomery Township. This ordinance authorizes the submission of a petition to the Franklin County Board of Commissioners, requesting that the boundary lines of Montgomery Township be changed to make them identical with the corporate limits of the city of Columbus for this annexation. The petition will be filed in accordance with Section 503.07 of the ORC. The subject site is also located within the City's Northeast Pay-As-We-Grow (PAWG) area and if developed will be subject to PAWG funding mechanisms applicable to the area.

FISCAL IMPACT: Provision of municipal services does represent cost to the City; however, the annexation of land also has the potential to create revenue to the City.

To accept the application (AN15-013) of Derrer Road LLC for the annexation of certain territory containing $3.354 \pm$ acres in Plain Township and to authorize the submission of a petition to the Board of Commissioners of Franklin County, Ohio, requesting a change in the boundary lines of Montgomery Township so as to make them identical with the corporate boundaries of the city of Columbus for this annexation.

WHEREAS, a petition for the annexation of certain territory in Plain Township was filed on behalf of Derrer Road LLC on June 26, 2015; and

WHEREAS, while a service ordinance is not required for this type of annexation, the City did conduct a review of the proposed annexation to determine what services would be available to the site upon annexation, the results of which are reflected in the attached service statement; and

WHEREAS, the proposed annexation site is located within the City's Northeast Pay-As-We-Grow (PAWG) area and is subject to the provisions of this program; and

WHEREAS, the petition was considered and approved by the Franklin County Board of Commissioners at a hearing on July 14, 2015; and

WHEREAS, on July 27, 2015, the City Clerk received from Franklin County a certified copy of the resolution addressing the petition; and

WHEREAS, sixty days have now elapsed since receipt of the resolution in accordance with the provisions of the Ohio Revised Code; and

WHEREAS, it is in the best interest of the City of Columbus to accept the annexation of the territory addressed by the petition; and

WHEREAS, the annexation agreement between Plain Township and the City of Columbus requires the City to transfer territory annexed from Plain Township to the city of Columbus and to conform the boundaries of Montgomery Township to make them identical with the corporate limits of the city; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the annexation proposed by Derrer Road LLC in a petition filed with the Franklin County Board of Commissioners on June 26, 2015 and subsequently approved by the Board on July 14, 2015 is hereby accepted and said territory is hereby annexed to the city of Columbus. Said territory is described as follows:

On October 3, 2012 the Columbus City Treasurer's Office issued a request for proposal SA004617 for various

banking services. The Columbus Depository Commission received and reviewed proposals from six (6) local banks and recommended, subject to the approval of City Council, the award of banking services to specific banks on April 18, 2013. All such banks are currently eligible depositories of the City of Columbus, pursuant to Chapter 321.04 of the Columbus City Code. On May 19, 2014, Columbus City Council authorized contracts and expenditures for the second year of banking services, ordinance number 1073-2014, for the period of June 1, 2014 through May 31, 2015.

On June 1, 2015, Columbus City Council authorized contracts and expenditures for the third year of banking services, ordinance number 1101-2015 for the period June 1, 2015 through May 31, 2016.

The City Treasurer's Office now wishes to modify its contracts to provide additional resources for banking with JP Morgan Chase. 1. BACKGROUND:

This ordinance authorizes the Director of Public Service to modify and increase the existing software, software licensing, and maintenance services contract with ReCollect Systems, Inc. to add the Waste Wizard application and to add funds for year three of the contract.

In November of 2013 the Department of Public Service entered into a three-year contract with ReCollect Systems to use their web application for the city's refuse, recycling, and yard waste programs. This application allows residents to search by address to determine collection dates, to populate a printable calendar to serve as a reminder for collection dates, to receive reminders about collection days, and to sign-up to receive emailed updates about the programs. There is also an administrative dashboard which provides metrics and allows customizable schedules.

In July of 2015, per ordinance 1436-2015, the Department of Public Service added ReCollect's street sweeping web application to the contract. The success of the refuse program demonstrated this type of interaction is useful to residents. This same interaction applied to the street sweeping program is expected to increase awareness of street sweeping times, reduce towing of resident vehicles, and increase street sweeping efficiency. The street sweeping web application is expected to be operational in early 2016.

The ReCollect Waste Wizard will be added to the contract through this ordinance. It is an on-line educational tool to assist users in finding organizations that will recycle or dispose of materials in an environmentally friendly way, diverting more materials from the landfill. It is meant to complement the city's residential recycling program with Rumpke.

The Department of Public Utilities maintains an effective environmental compliance program in order to maintain consistent compliance with environmental laws and regulations and to reduce any environmental impacts associated with its various activities. As part of the Department's Environmental Management System development process, DPU requires audit and registration services to obtain and maintain third-party certification of its conformance with the International Organization for Standardization (ISO) Standards (ISO 14001:2004 Standard) and to sustain an effective EMS program through yearly surveillance audits.

DPU is responsible for the daily administration, operation and maintenance of the City of Columbus water supply and distribution system including three (3) water treatment plants; sanitary and storm water collection and treatment system including two (2) waste water treatment plants and a bio-solids composting facility; and electricity power distribution including numerous power substations and transformers. CITY DEPARTMENTS' RECOMMENDATION: Approval. The site consists of commercial buildings and two dwellings, and is zoned in the EF, East Franklinton District within the Dodge Park Sub-District. The applicant, Pilot Dogs, proposes redeveloping the site with a mixed-use building, including veterinary offices and kennels, to be used in conjunction with their existing guide dog training facility, which is located just west of the site at 625 West Town Street. The Pilot Dogs operations currently exist on two separate properties that are several miles from each other. This proposal will consolidate the operations by relocating their facility on Stimmel Avenue to the subject site. The East Franklinton District is an urban, mixed use zoning classification that was established in 2013 as a new zoning tool to implement the land use recommendations of the East Franklinton Creative Community District Plan (2012). The variance is required because the proposed kennel use is not listed as a permitted use within the EF district. The East Franklinton Creative Community District Plan recommends medium-density mixed residential development for the Dodge Park Sub-District. The East Franklinton Review Board has issued a Certificate of Approval for the use variance necessary for the accessory kennels, as Pilot Dogs has been a staple of this community for over sixty years. A Certificate of Approval will also be required for the building and site design as part of the site compliance review process.

To grant a variance from the provisions of Section 3323.19, Uses, of the Columbus City codes; for the property located at **577 WEST TOWN STREET (43215)**, to permit accessory kennels in conjunction with a mixed-use office and veterinary facility used for guide dog training in the EF, East Franklinton District (Council Variance # CV15-046).

Hotels and motels, except for those hotels greater than one story and with three or fewer main access points for hotel guests;

Extended stay hotels;

Limousine and taxi services;

Motorcycle and boat dealers;

Truck, utility trailer, and recreational vehicle sales, rental and leasing;

Automotive maintenance and repair, except as associated with an automotive sales operation;

Employment Services and Placement Agencies;

Blood and Organ Banks; and,

Halfway Houses.

In the case of Automotive sales, leasing and rental, used automobiles may be sold only in connection with new automobile sales.

- **3. Development Standards**: Unless otherwise indicated, the applicable development standards are contained in Chapter 3356 C-4, Commercial of the Columbus City Code.
- **a. Density, Height, Lot, and /or Setback Commitments**: Standards are per the underlying zoning classification contained in Chapter 3356 C-4, Commercial of the Columbus City Code per the limitations set forth below:
- i. For wireless communication facilities, the maximum height shall be 91 feet.
- ii. If redevelopment would occur on this site that includes the demolition of buildings, right-of-way of 110' from centerline along the Morse Rd. frontage shall be dedicated to the City of Columbus. The provisions of the preceding sentence shall not apply if an existing building or existing parking area within this future right-of-way dedication area would still be present upon redevelopment.
- b. Access, Loading, Parking and/or other Traffic related commitments.

Primary access to the property will be from Morse Road or a future public access road along the North side of Morse Road.

c. Buffering, Landscaping, Open Space, and / or Screening Commitments: Buffering and landscaping shall be in accordance with Chapter 3356 C-4, Commercial of the Columbus City Code per the limitations set forth below:

There shall be maintained along the entire northerly property line and along a portion of the westerly property line of the tract a land berm of no less than six feet high on the portions of the west side and a land berm of between two and three feet high on the north side. Such berm will be a minimum 25 feet in width and planted with existing vegetation of no less than 20 trees of varying height and species, to be maintained by the property owner so as to provide substantial vision, light and sound screening from the residential lots to the north and west of the tract. The berm and screening shall resemble the "Tree and Berm Survey," dated October 5, 2015, and attached hereto.

There shall also be maintained a four foot high chain link fence in the berm no less than 10 feet from the westerly property line. The property owners contiguous to the berm on the westerly side shall be permitted to maintain that portion of the berm and mounding directly contiguous to their property. The building and parking setbacks for the westerly and northerly portions of the property containing the described berm shall be no less than 25 feet.

d. Graphics and Signage Commitments

All graphics shall conform to Article 15 of the Columbus City Code, as it applies to the C-4 Commercial District and the Morse Road Regional Commercial Overlay. Any variance to the applicable requirements of the C-4 district shall be submitted to the Columbus Graphics Commission.

e. Wireless Telecommunications Facility

The development of a wireless telecommunications facility shall be permitted, including a monopole tower of a height not to exceed 91' and associated support structures and facilities, as depicted on the plans attached hereto as "Detailed Site Plan," and "Tower & Details," and made a part hereof, on the easterly portion of the tract indicated on the "Tree and Berm Survey".

The wireless telecommunications facility shall be developed in accordance with the plans "Detailed Site Plan," and "Tower & Details". The plans may be slightly adjusted to reflect engineering, topographical or other site data developed at the time that development and engineering plans are completed. Any slight adjustment to the plan shall be reviewed and may be approved by the Director of the Department of Building and Zoning Services or his or her designee upon submission of the appropriate data regarding the proposed adjustment.

BACKGROUND: This ordinance authorizes the expenditure of up to \$2,000,000.00 from the Housing Preservation Fund 782 to assist in the costs of redevelopment for the area known as Poindexter Village. The funds will assist with the development of mixed income rental housing and act as local match for the Choice Neighborhoods grant made to the Columbus Metropolitan Housing Authority.

The Columbus Metropolitan Housing Authority (CMHA) is undertaking a \$250 million, multi-phase redevelopment of the Poindexter Village area. The area runs to Mt. Vernon Avenue to the north, Ohio Avenue to the west, Long Street to the south and Hughes Street to the east.

In June 2014, the U.S. Department of Housing and Urban Development (HUD) awarded CMHA a \$30 million Choice Neighborhood Implementation (CNI) grant to begin the redevelopment of the Poindexter Village area. WHEREAS, the current phase requires the Director of the Department of Development to enter into a grant agreement with CMHA to allow the expenditure of up to \$2,000,000.00 from the Housing Preservation Fund to assist with the development of mixed income rental housing; and

WHEREAS, these funds will act as local match for the Choice Neighborhoods Implementation grant awarded to the Columbus Metropolitan Housing Authority; and

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Director of the Department of Development is authorized to enter into a grant agreement with the Columbus Metropolitan Housing Authority (CMHA), or a subsidiary of, to make financial assistance available for the redevelopment of the area known as Poindexter Village.

SECTION 2. That for the purpose stated in Section 1, the sum of up to \$2,000,000.00 or so much thereof as may be needed, is hereby authorized to be expended from the Housing Preservation Fund as follows:


SECTION 3. That the monies authorized in the foregoing Section 2 shall be paid upon the order of the Director of the Department of Development and that no order shall be drawn or money paid except by voucher, the form of which shall be approved by the City Auditor.
