### 1. BACKGROUND

The purpose of this legislation is to amend an earlier ordinance to facilitate the execution of a Contribution Agreement between the Department of Public Service and the Columbus State Community College Development Foundation Inc. relative to the Miscellaneous Economic Development - Creative Campus Phase 2 project.

Ordinance 2896-2017 previously authorized the Director of Public Service to enter into a Design Guaranteed Maximum Reimbursement Agreement with the Columbus State Foundation for the aforementioned Project, which encompasses various improvements to Cleveland Avenue between Long Street and Mount Vernon Avenue, in connection with Columbus State Community College's new culinary school project. Since that time, the Department of Public Service has determined that it would be more prudent to execute a Contribution Agreement relative to that effort.

Additionally, this legislation clarifies that the signatory to the aforementioned Contribution Agreement will be the Columbus State Community College Development Foundation Inc. and corrects the project name.

# 2. FISCAL IMPACT

The City previously committed \$350,000.00 toward eligible Project design costs, and an Auditor's Certificate, ACPO002492, has already been established allocating capital funds for that purpose. No additional monies will be encumbered or expended pursuant to this ordinance.

# 3. EMERGENCY DESIGNATION

Emergency action is requested so as to allow for the immediate execution of the requisite Contribution Agreement, which is necessary to facilitate the design of these improvements, in order to maintain the project schedule and to meet community commitments.

# 1. BACKGROUND

This ordinance authorizes the Director of Public Service to execute an agreement with the Ohio Department of Transportation relative to the construction of the FRA-315-0.49 (SR 315 Resurfacing) project, PID 76420, and to contribute additional funding for that purpose.

The scope of work for the aforementioned project encompasses resurfacing SR-315 from Sullivant Avenue to the pavement break where the I-670 ramp joins SR-315, which is approximately ¾ mile south of the King Avenue exit, and resurfacing SR-315C (Goodale Street) from the I-670 off ramp to Goodale Street, the Michigan Avenue Connector, along the Goodale/Nationwide connector or SR-315, north on Olentangy River Road, to the SR-315 southbound on ramp. Ordinance 2823-2014 authorized the Director of Public Service to grant consent and propose cooperation with ODOT relative to that effort, and Ordinance 2951-2017 authorized the Director of Public Service to enter into agreement with and to provide funding to ODOT in the amount of up

to \$220,000.00 to pay the local share of estimated construction costs.

The apparent low bid, received by ODOT on December 14, 2017, exceeded the original cost estimate. As such, the proportionate share of construction costs to be borne by the City has increased. The purpose of this legislation is to authorize the encumbrance and expenditure of additional funds in the amount of \$35,472.00 to satisfy the City's cost share obligation to ODOT for the project.

# 2. FISCAL IMPACT

# **Background:**

This legislation authorizes Franklin County Municipal Court, Clerk of Court ("Municipal Court Clerk") to modify the existing contract with the Law Offices of Robert A. # 1. BACKGROUND

This legislation authorizes the Director of Public Service to refund the unused portion of deposits made by the Central Ohio Transit Authority (COTA) for the acquisition of right-of-way for the Roadway Improvements - COTA Bus Rapid Transit (BRT) project.

The BRT is a 15.6-mile high capacity transit project comprised of a combination of BRT services operating in mixed traffic primarily along Cleveland Avenue between downtown Columbus and SR-161, with enhanced bus service continuing north to Polaris Parkway and Africa Road, connecting commuters with various land uses along the corridor through the City of Columbus, Clinton Township, and the Village of Minerva Park in Franklin County, terminating in the City of Westerville in Delaware County. The BRT line will utilize an operational strategy that facilitates the movement of in-service transit vehicles through traffic-signal controlled intersections known as the Traffic Signal Priority (TSP) System, which endeavors to reduce transit vehicle travel times and transit schedule variability while minimizing the impact to conventional traffic using the same road network.

Pursuant to Ordinance 0567-2015 and Ordinance 2967-2016, the Director of Public Service and COTA entered into right-of-way acquisition agreements whereby COTA made deposits totaling \$550,000.00 for the acquisition of various property rights attributable to the BRT project. The ordinance also provided for the refund of any portion of the deposits not used for the project right-of-way acquisition after final accounting was performed.

Final accounting determined \$521,815.38 was spent on BRT right-of-way acquisition, requiring a refund to COTA of \$28,184.62. During final accounting it was discovered payments for right-of-way on another COTA project were charged to the BRT project. This has resulted in a shortage of \$7,334.96 in the BRT right-of-way account, which must be corrected to fully refund the money owed to COTA.

# 2. EMERGENCY DESIGNATION

Emergency action is requested to allow for the immediate refund of unused funds deposited by COTA.

## 3. FISCAL IMPACT

\$20,849.66 of the \$28,184.62 is available from COTA's deposits in fund 7766, the Street and Highway Improvements (Non-Bond) Fund, on ACDI000339-10. Due to some incorrect payments and expenditure corrections, the balance on ACDI000339-10 is \$7,334.96 less than it should be. The remainder of the refund is available in Fund 7766 Street and Highway Improvements (Non-Bond) Fund in the generic Roadway Improvements project and will need to be transferred to the COTA BRT project.

To authorize the cancellation of funds for an unused deposit; to amend the 2017 Capital Improvement Budget; to authorize the transfer of cash and appropriation within the Street and Highway Improvements (Non-Bond) Fund; to authorize the Director of Public Service to refund to the Central Ohio Transit Authority (COTA)

unused funds deposited by COTA for the Roadway Improvements-COTA BRT project; to authorize the expenditure of up to \$28,184.62 from the Street and Highway Improvements (Non-Bond) Fund for the refund to COTA; and to declare an emergency. (\$28,184.62)

WHEREAS, the Central Ohio Transit Authority (COTA) intends to construct or cause to be constructed a 15.6-mile high-capacity transit project comprised of a combination of BRT services operating in mixed traffic primarily along Cleveland Avenue between downtown Columbus and SR-161, with enhanced bus service continuing north to Polaris Parkway and Africa Road, known as the Roadway Improvements-COTA BRT project; and

WHEREAS, Ordinance 0567-2015 authorized the Director of Public Service to enter into agreements with COTA in connection with the BRT project, to accept deposits in the amount of \$350,000.00 from COTA for right-of-way acquisition by the City Attorney's Office, Real Estate Division, for the BRT project, and to, as necessary, provide refunds to COTA after the construction of the project has been completed; and

# **BACKGROUND:**

This ordinance will authorize the Directors of the Departments of Technology and Public Utilities to continue the annual agreement with Labworks, LLC, for the maintenance and support of the Laboratory Information Management System (LIMS). The original agreement (EL008929) was authorized by ordinance 1738-2008, passed November 24, 2008. The agreement was most recently continued under the authority of ordinance 1081-2017, passed June 12, 2017, through PO072433, for software maintenance and support services. This contract agreement will provide software maintenance and support services for the term period June 1, 2018 through May 31, 2019, at a cost of \$52,194.00.

LIMS enables the Division of Sewer and Drainage (DOSD) and the Division of Water (DOW) to manage water quality sample information, incorporate input from plant operations data sources, track over 79,000 tests on 16,000 different samples annually, and transfer approved results to end users automatically. The LIMS system allows DOSD and DOW to satisfy their regulatory reporting requirements more efficiently. This annual maintenance and support agreement is needed to provide for updated LIMS software and access to LIMS technical support. Without this agreement, the City would need to pay a substantially higher new license fee to obtain the latest version of LIMS software, and would be unable to resolve problems with the software requiring LIMS technical support.

This ordinance also requests approval to continue services provided by Labworks, LLC., Inc. in accordance with sole source procurement provisions of Chapter 329 of the Columbus City Code; as it has been determined Labworks, LLC. is the sole distributor of LIMS, and does not utilize distributors or re-sellers due to the complex nature of its product.

#### **FISCAL IMPACT:**

In 2016 and 2017, \$49,731.00 and \$51,006.00 respectively was legislated for software maintenance and support services to support the Laboratory Information Management System (LIMS). The Director of Public Utilities entered into a contract with Righter Company, Inc. to provide Specialty Maintenance Crafts for various Divisions of the Department of Public Utilities, FEM Project No. 0101.5. This renewal No. 3 is to add additional funding for repairs at various locations of the Division of Sewerage and Drainage and the Division of Power.

The Department of Public Utilities advertised Request for Proposals (RFP's) for the subject services, in the City Bulletin in accordance with the relevant provisions of City Code Section 329 (SA005659). Ninety-one (91) vendors (82 MAJ, 3 MBE, 6 M1A) were solicited and one (1) proposal (1 MAJ), from Righter Company, Inc., was received on December 4, 2014. The proposal was reviewed based on quality and feasibility and Righter Company, Inc. was determined to be qualified to provide the services for the Specialty Maintenance Crafts project, for which the Director of Public Utilities and the Division of Sewerage and Drainage Administrator have concurred. The original contract was for a period of one year with three (3) one year renewal options on a year-to-year basis upon mutual agreement, availability of funding, and Columbus City Council approval. This is the 4th year of a four (4) year contract. This contract renewal No. 3 will extend the contract through and including May 7, 2019.

Note: The RFP included three (3) projects and the top three (3) ranked firms were selected for these projects. The Division of Water determines which projects were to be awarded to each of the top 3 ranked firms. An evaluation committee reviewed the proposals and scored them based on the criteria mentioned above. The Department of Public Utilities recommends that the Chestershire Road Water Line Improvements Project be awarded to Stantec Consulting Services, Inc.

Matic Insurance Services Inc. intends to lease, renovate, and occupy approximately 12,000 square feet of office space at 2 Miranova Place, Suite 400, Columbus, Ohio 43215 ("Project Site") in the Riversouth District. The expansion of this client's services center and establishment of legal and administrative offices will support new integration partnerships and provide access to a diverse and talented pool of prospective employees. Matic Insurance Services Inc. will invest approximately \$400,000 related to leasehold improvements and equipping the Project Site. Matic Insurance Services Inc. anticipates retaining 10 existing full-time permanent positions with an associated annual payroll of approximately \$645,000 and expects to create 50 new full-time permanent positions with an associated annual payroll of approximately \$3,317,000.

**BACKGROUND:** Columbus Public Health has been awarded a grant from the Ohio Department of Health to support the expansion and implementation of Naloxone Education and Street Outreach Program (NESOP), called Project DAWN. This ordinance is needed to accept and appropriate \$14,250.00 in grant monies to fund the Project DAWN Expansion grant program for the period of January 1, 2018 through June 30, 2019.

The Project DAWN Expansion Grant will eliminate social and geographic barriers that might prevent individuals from acquiring naloxone, provide overdose prevention education, and furnish naloxone. The program will also identify a fixed location at a Columbus Fire Department substation where naloxone can be acquired.

In the first six months of 2017, the Franklin County Coroner reported an 88% increase in accidental overdose death compared to the same time-period in 2016: with overdose death rising from 143 between January 1st and June 30th of 2016 to 268 in 2017's first six months. The increased pollution of street drugs with fentanyl has

caused the illicit drugs to become more deadly, putting residents who either use drugs recreationally or who are living with a substance use disorder at extreme risk of accidental overdose death. The life-saving drug naloxone has been critical in reversing the dangerous effects of an overdose and saving lives.

Emergency action is requested to ensure that Columbus Public Health has the sufficient amount of these supplies and services to protect the health, safety, and welfare of the residents of Columbus.

**FISCAL IMPACT:** The Project DAWN Expansion Program grant is fully funded (\$14,250.00) by the Ohio Department of Health and does not require a City match.


