1. BACKGROUND

This legislation authorizes the Director of Public Service to establish an encumbrance within the Special Income Tax Fund to pay 2020 waste disposal tipping fees for the Division of Refuse Collection and to expend funds to pay the tipping fees. This expense is necessary to safely and contractually dispose of the waste collected by the division in the course of pursuing its mission by providing residential refuse collection services to over 320,000 households weekly, picking up bulk items and illegally dumped items as needed, and to provide radiation remediation services to process quarantined loads at SWACO tipping sites.

The Department of Public Service has determined that \$17,128,000.00 should be adequate for this purpose. This number is based upon an estimated waste stream of 319,000 tons in 2020. Actual tonnage is ultimately dependent on variables such as the weather, the actual number of households collected that cannot be specifically calculated at this time, and the unknown amount of bulk and illegally dumped items. If necessary, additional legislation will be submitted to increase funds at a later date.

Previous calendar years' actual tipping fee expenditures totaled \$16,656,304.00 (2017), \$16,763,000.00 (2018), and \$16,767,000.00 in 2019. SWACO tipping fee rates are determined by SWACO's established rate setting process. Due to an existing contractual relationship where the City of Columbus participates in the rate setting process, the City is required to use SWACO waste disposal services. The vendors and waste disposal fees for tire disposal services, construction/demolition material disposal services, and radiation remediation services will be determined through the city's competitive bidding process.

2. FISCAL IMPACT

This 2020 expense is budgeted within the Special Income Tax Fund and is part of Ordinance 2927-2019 tabled by Council on 11/18/2019. This ordinance is contingent upon passage of the 2020 operating budget, and Ordinance 2927-2019 authorizing the use of Special Income Tax fund monies.

Ordinance 2927-2019 authorizing the use of Special Income Tax Fund money for waste disposal tipping purposes has to be approved by Council before this encumbrance can be established. Per the contract with SWACO, the City is subject to late fees for all invoices not paid within the due date. Emergency action is requested to avoid delays of payment to SWACO that could result in the city incurring interest penalties as specified within the contract.

To authorize the expenditure of \$17,128,000.00 or so much thereof as may be necessary from the Special Income Tax Fund to pay 2020 waste disposal tipping fees for the Division of Refuse Collection; to authorize the

Director of Public Service to establish an encumbrance of \$17,053,000.00 to pay refuse tipping fees to the Solid Waste Authority of Central Ohio for the Division of Refuse Collection pursuant to an existing lease agreement; to establish encumbrances up to \$25,000.00 for tire disposal and construction/demolition material disposal; to establish an encumbrance up to \$50,000.00 for radiation remediation services; and to declare an emergency. (\$17,128,000.00)

WHEREAS, the Division of Refuse Collection must encumber funds to continue refuse tipping at the Solid Waste Authority of Central Ohio (SWACO) facilities, pursuant to the lease agreement between the City and SWACO for those facilities, and must encumber funds for disposal of tires, construction/demolition material disposal, and radiation remediation services; and

WHEREAS, the Department of Public Service has determined that \$17,128,000.00 should be adequate for this purpose and is based upon an estimated waste stream of 319,000 tons in 2019; and

WHEREAS, actual tonnage is ultimately dependent on variables such as the weather, the actual number of households collected that cannot be specifically calculated at this time, and the unknown amount of bulk and illegally dumped items; and

WHEREAS, if necessary, additional legislation will be submitted to increase funds at a later date; and

WHEREAS, the vendors and waste disposal fees for tire disposal services, construction/demolition material disposal services, and radiation remediation services will be determined through the city's competitive bidding process; and

BACKGROUND: Columbus Public Health has been awarded additional funding from the Ohio Department of Health, Bureau of Health Services, Violence and Injury Prevention Section. This ordinance is needed to accept the additional funding of \$50,000.00 in grant monies to provide additional funding for the Child Injury Prevention grant program for the period of February 1, 2020 to June 30, 2020.

The Initial Term of the contract with Active Network LLC, signed in February 2017, for maintenance and support of the Activenet software application has concluded. Upon the completion of the Initial Term, the contract provides for automatic renewals for two (2) year terms until either party gives written notice to terminate the Hosted Software no less than twelve (12) months prior to the end of the Renewal Term.

This ordinance will authorize the Director of Recreation and Parks to enter into the first year of the first two (2) year Renewal Term with Active Network LLC, to waive the competitive bidding provisions of the Columbus City Code Chapter 329, and authorize the expenditure for this agreement.

Background: Activenet has been the hosted online registration system for class registration at CRPD since 2008 when a bid process was used to select them. This software also provides for accurate accounting and a means to audit revenues collected in relation to the above activities.

Passage of this legislation will authorize the Director of the Recreation and Parks Department to enter into year one (1) of a two (2) year agreement with Active Network, LLC for hosted software, support and maintenance in the total amount of \$170,000.00 for the period of March 1, 2020 through February 28, 2021, to waive the competitive bidding provisions of the Columbus City Code Chapter 329 and to declare an emergency. This Ordinance is submitted to settle the lawsuit captioned *Carla Hoover, et al. v. Steven G. Rosser, et al.*, United States District Court Case No. 2:19-cv-01453, in the amount of One Hundred Eighty Five Thousand Dollars (\$185,000.00). This amount will be made payable to Cooper & Elliott, LLC IOLTA, in six separate checks, for the following six Plaintiffs: \$35,000 for Carla Hoover, \$30,000 for Emily Haudenschield, \$30,000 for Brittany Yates, \$30,000 for Danielle Calderon, \$30,000 for Ashley Graves, and \$30,000 for Chelsea Paige Ewart.

Plaintiffs Carla Hoover, Emily Haudenschield, Brittany Yates, Danielle Calderon, Ashley Graves, and Chelsea Paige Ewart were criminally charged by either former Columbus Police Vice Officer Steven Rosser or former Columbus Police Vice Officer Whitney Lancaster with violating O.R.C. § 2907.40(C)(2) "illegal oriented activity in sexually oriented businesses." Plaintiffs allege that Rosser and Lancaster falsely swore out the criminal complaints against them. Plaintiffs allege that they were charged without probable cause in violation of their Fourth and Fourteenth Amendment rights and the City's policies and practices were the moving force behind their arrests.

Fiscal Impact:

Funds were not specifically budgeted for this settlement; however, sufficient monies are available within the 2020 general fund budget to pay the amount of this claim. This ordinance is contingent upon passage of the 2020 General Fund Budget.

This ordinance is to authorize the Director of the Recreation and Parks Department to enter into contract with The Righter Co., Inc. to perform construction work regarding pump station improvements on Champions Golf Course.

Background: This is the second phase of a two phase project. Phase one was the replacement of the main irrigation line and drainage work and was completed in 2019. Phase two was aligned with the improvements for the Champions Clubhouse project which included an electrical system upgrade for the Champions Golf Course site. The new electric service permits us to replace the aging pump station, including control panel, pumps and motors, and associated equipment. The pump station is critical equipment responsible for running the Golf Course's irrigation system. Without upgrading the pump station equipment, the irrigation system would not function, and the Golf Course could experience a significant damage to the playing surfaces during the dry summer months.

Bids were advertised through Vendor Services, in accordance with City Code Section 329, on January 3rd, 2020 and received by the Recreation and Parks Department on January 28st, 2020. Bids were received from the following companies:

After reviewing the proposals that were submitted, it was determine that The Righter Co., Inc. was the lowest and most responsive bidder. All proposed subcontractors have met code requirements with respect to prequalification, pursuant to relevant sections of Columbus City Code Chapter 329.

Technical Choice is not pre-qualified through the Office of Finance and Management, and neither is their electrical subcontractor Brett Short Circuits, LLC. Per City Code 329.20 (c), Technical Choice LLC is non-responsive and the bid cannot be considered for award without an approved bid waiver by Director Rakosky and City Council.

BACKGROUND: This legislation authorizes the Finance and Management Director to establish Universal Term Contracts (UTC) for the option to purchase Electric Conductor, Wire and Cable with American Wire Group, Consolidated Electrical Distributors, Inc., Utility Supply and Construction Company dba Power Line Supply, and Wesco Distribution, Inc. The Division of Power is the primary user of these commodities as they are used in the City's electrical distribution system. The term of the proposed option contracts would be approximately one(1) year, expiring March 31, 2021, with the option to renew for three (3) additional years. In addition, the expenditure of \$4.00 is hereby authorized from General Budget Reservation BRPO001107.

The Purchasing Office advertised and solicited competitive bids in accordance with the relevant provisions of Columbus City Code 329 relating to competitive bidding, (Request for Quotation No. RFQ014459). The Purchasing Office opened formal bids on January 23, 2020. Four bids were received. Two of the bidders failed to complete the bid worksheets correctly. One company used an older version of the worksheet and the other bidder did not complete one column of the worksheet. These omissions did not affect the ability to accurately evaluate each bidder's response. These two bidders were the low bidder on a significant number of items. The recommendation is for a waiver to allow all items to be awarded to the lowest bidder.

Since 1998, Columbus Public Health has contracted with Columbus Neighborhood Health Center, Inc. (CNHC), a not-for-profit corporation, to provide primary health care services to medically indigent patients at various neighborhood health centers. This ordinance authorizes the Board of Health to enter into a contract with Columbus Neighborhood Health Center, Inc. (dba PrimaryOne Health) to provide primary health care, home visiting and dental services at community-based health centers for a total amount of \$4,299,110.00 for the period of January 1, 2020 through December 31, 2020. Community Health Centers (CHC) are successful, low-cost options for primary care access in a nation that spends \$2 trillion a year on health care. Medical costs for CHC patients are 41% lower compared to patients seen elsewhere such as a hospital emergency room. As a result CHC's save the healthcare system between \$9.9 billion and \$17.6 billion a year.

Emergency action is requested in order to ensure timely payments to the contractor.

BACKGROUND:

This ordinance authorizes the Public Safety Director, on behalf of the Division of Support Services, to renew a contract with Day Funeral Services in the amount of \$180,000.00 to continue to provide indigent cremations as needed for the City of Columbus.

Ord 0485-2019 authorized the Public Safety Director, on behalf of the Division of Support Services, to enter into a contract with Day Funeral Services to provide indigent cremations as needed for the City. Ohio Revised Code Section 9.15 requires that the City be responsible for the cost of burial or cremation of an indigent person. The scope of services outlined in the City's Request for Proposal include: processing, negotiating, and auditing prisoner medical claims.

Bid Information: Formal Bid # RFQ010964 was opened on November 27, 2018 to create a new process for indigent cremations. Multiple responses were received. An evaluation committee was put together comprised of personnel from the Division of Support Services, Health, the Department of Public Safety's Director's Office, and the Franklin County Coroner's office. Based on the average score from the committee, the bid was recommended to be awarded to Day Funeral Services.

The specifications within the RFP allow for the option of three (3), one (1) year renewals. This extension is the first of the three (3) renewals. (April 1, 2020 - March 31, 2021)

SUPPLIER: Day Funeral Service, Vendor#012847, contract compliance# 61-1688640, expires 12/18/2020

This company is not debarred according to the Federal excluded parties listing or prohibited from being awarded a contract according to the Auditor of State's unresolved findings for recovery certified search.

- 1. <u>Amount of additional funds</u>: Total amount of additional funds needed for this contract modification is \$180,000.00. The Division will request additional future modifications as additional work orders are approved. Total contract amount including this modification is \$360,000.00.
- 2. Reasons additional funds were not foreseen: The need for additional funds was known at the time of the initial contract. This modification is to provide the additional funding necessary for the payment of services to be provided through March 31, 2021.
- 3. <u>Reason other procurement processes were not used:</u> This is a planned modification to provide professional services for indigent cremations.
- 4. <u>How was cost determined</u>: The costs of this modification were based on estimated monthly consultant invoice amounts. The cost, terms and conditions are in accordance with the original agreement.

These are funds that CCS has provided to The City of Columbus, Department of Technology (DoT) to pay for supplies, services and capital equipment associated with the Voice-over-Internet-Protocol (VOIP) telephone project.

Per ordinance 2557-2017 passed by City Council October 30, 2017, and all exhibits, this on-going project is a collaborative partnership between the city and the schools. As the city expands its VOIP solution, services and equipment are made available to the schools and the schools are, in turn, reimbursing the city for incurred costs. BACKGROUND: The City of Columbus, Division of Public Safety received three years of *Overdose Data to Action* funding from the U.S. Centers for Disease Control and Prevention (CDC) via a sub award from Franklin County Public Health (FCPH). This sub award addresses the local opioid crisis by expanding capacity of Rapid Response Emergency Addiction Crisis Team (RREACT) and increasing linkage to RREACT outreach and education services. This ordinance accepts and appropriates year one project funds totaling \$371,523. The full project award period is three years with a total award amount of \$1,114,569. The 2019 award budget period is November 1, 2019 through August 31, 2020. The full award period is November 1, 2019 through August 31, 2022. This ordinance authorizes an appropriation of funds upon receipt of annual executed agreements.

Rapid Response Emergency Addiction Crisis Team (RREACT) is an innovative outreach effort addressing the opioid crisis ravaging Columbus, Ohio. RREACT team members go out into the community and do face-to-face follow up visits with substance users revived from opioid overdose by police or fire first responders but then refuse immediate transport to clinical facilities thereby bypassing treatment and recovery resources available through emergency rooms across the city. RREACT connects with survivors in their neighborhoods within 48 hours of overdose. The team includes a Crisis Intervention Team (CIT) trained peace officer, a paramedic, a social worker and a trauma specialist. The goal of this multi-disciplinary outreach team is to help stabilize the household in an effort to reduce barriers to accessing drug and/or behavioral treatment for the substance user. CDC funding will expand mobile crisis response capacity with the addition of a second RREACT outreach squad. The additional squad will provide outreach in high-risk areas of Columbus, specifically townships within the County heavily impacted by opioid use but lacking infrastructure and funding to provide outreach through their local EMS and fire teams. In addition to direct outreach services, RREACT leadership will build relationships with suburban law enforcement teams to gain countywide buy-in for adopting naloxone/NARCAN© administration as standard protocol for opioid overdose incidents. CDC funds will support total compensation for one CDF paramedic/firefighter, one CIT trained peace officer; a vehicle for outreach and patient transport; contract costs for one additional substance use case manager and one cell phone for the second outreach team.

EMERGENCY ACTION: This ordinance is submitted as an emergency as to not delay program services and to allow the financial transactions to be posted to the City's accounting system as soon as possible.

FISCAL IMPACT: This ordinance authorizes the acceptance and appropriation of \$371,523.00 in year one U.S. Centers for Disease Control and Prevention award monies from Franklin County Public Health to fund expansion of RREACT outreach activities. This initiative does not generate any revenue nor require a City match.

The term of the contract is three years, with the option to extend, upon mutual agreement, for two additional one-year contracts. The cost for year one is \$55,000.00.

CareWorks Comp has been the city's third-party administrator for the workers' compensation cost containment program since March, 2009. The term of the current contract is from March 1, 2020 to February 28, 2021. BACKGROUND: This legislation authorizes the Director of Public Safety to pay the City of Columbus' proportionate share for the operation and administration of the Franklin County Emergency Management and Homeland Security program (FCEMHS), including the countywide mass notification system. The FCEMHS is responsible for managing the outdoor warning siren system within Franklin County not only by coordinating siren locations but also by providing for their maintenance, relocation, and activation. The Agency's operational activities also include planning for disaster recovery, public education, and exercises.

The FCEMHS is also serving as the lead agency for the implementation and maintenance of a mass warning and notification system designed to meet the needs of forty-two jurisdictions and emergency partners in Franklin County. A mass notification system can reach residents in the form of phone messages, text messages, and email. Other considerations include preferred languages and mechanisms to reach the hearing and vision impaired, and those with other special needs within the community. The city's participation with FCEMHS is in accordance with State law. All activities of the agency are supported by local government funds and some federal grants.

Emergency Designation: Emergency designation will ensure timely payments to FCEMHS.

1. BACKGROUND

The Ohio Department of Transportation (ODOT) annually accepts applications to fund projects using Safe Routes to School (SRTS) program funds. SRTS funds are available to communities as grants to be used to improve the ability of elementary and middle school students to walk and bicycle to school safely. A community may be awarded up to \$400,000 for an infrastructure project. March 6, 2020, is the deadline for the current Safe Routes to School application cycle.

The Department of Public Service is preparing a Safe Routes to School application, with a current focus on constructing new sidewalks and filling existing sidewalk gaps on Grace Street, from Orel Avenue to Eureka Avenue. Public Service will be funding the design of the project as part of the Operation Safewalks program.

This project will benefit students walking to school and school bus stops in the area. The Columbus City Schools District-Wide Travel Plan identified Grace Street as a priority corridor for West Broad Elementary School. Walking is a significant mode at West Broad Elementary School, with approximately 35% of students walking to school.

2. EXPECTED PROJECT

The Department of Public Service plans to submit an application for the following project:

Operation Safewalks - Grace Street - Orel Avenue to Eureka Avenue: This project will perform work along a priority corridor for West Broad Elementary School. This project will add sidewalk along Grace Street from Orel Avenue to Eureka Avenue. The current project cost estimate is \$ 2,280,000.00.

This listing is meant to be illustrative and is believed to be accurate and complete; however, last minute project additions and substitutions are at the discretion of the Director of Public Service.

BACKGROUND: This ordinance is being submitted to set forth the municipal services and zoning conditions the city of Columbus will provide upon annexation of a territory located in Mifflin Township. This ordinance is required by the Ohio Revised Code (ORC) as enacted by the General Assembly of the State of Ohio. An annexation petition has been filed with Franklin County for this property. A service ordinance must be passed before the annexation meeting takes place before the Board of County Commissioners of Franklin County. Information regarding municipal services that would be available, should the subject site be annexed, has been compiled and is reflected in this ordinance. Should the petition be approved by the County Commissioners, a second City ordinance accepting the annexation will be required to complete the process. The time frames specified in the ORC require that this legislation be filed as emergency.

FISCAL IMPACT: The statement of municipal services and zoning conditions for a proposed annexation area has no fiscal impact. While provision of the stated services does represent cost to the City, annexation of land also has the potential to create revenue to the city.

To set forth a statement of municipal services and zoning conditions to be provided to the area contained in a proposed annexation (AN20-001) of $4.00\pm$ Acres in Mifflin Township to the city of Columbus as required by the Ohio Revised Code and to declare an emergency.

WHEREAS, a petition for the annexation of certain territory in Mifflin Township was duly filed on behalf of BMU4 LLC on February 11, 2020; and

WHEREAS, a hearing on said petition is tentatively scheduled before the Board of County Commissioners of Franklin County on March 10, 2020; and

WHEREAS, the Ohio Revised Code requires that before said hearing the Municipal Legislative Authority shall adopt a statement indicating what services, if any, the municipal corporation will provide to the territory proposed for annexation upon annexation; and

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS

Section 1. That the city of Columbus will provide the following municipal services for $4.00\pm$ acres in Mifflin Township upon the annexation of said area to the city of Columbus:

Public Safety: The City of Columbus, Department of Public Safety will be able to provide the appropriate level of safety related services to the proposed annexation area. Such services will include police and fire protection as well as emergency medical service to the subject property.

While the petitioner for annexation may have proposed future development plans for the property in question, the Department of Public Safety requests that the City exercise its discretion in the coming development planning and review process to ensure any future development will be properly served by the Department of Public Safety. Discussions between the City and the present property owner or any future developers regarding post annexation changes in zoning or other changes to the property should include the Department of Public Safety and the Department of Development to ensure any proposed development of the annexation property may be adequately accommodated. Specific details for safety services are dependent upon the parameters of future development that is ultimately approved by the City.

Sanitation: Residential refuse collection services will be available upon annexation of the property.

Transportation: Maintenance will be available for any additional right-of-way that may be included in this annexation request. If this annexation contains existing signalized intersections, those intersections and signals are subject to Transportation Division Policy, which appeared in the December 6, 2003 Columbus City Bulletin, and any subsequent updates thereto.

Water: The site will be served by an existing 48" water main located in Stelzer Road, the connection to which will be made the owner's expense.

Sewers: All sanitary and storm sewers required shall be constructed privately by the owners and developers at their own cost and expense with no cost to the City.

Sanitary: This site can be served by a sanitary mainline extension, extending to adjacent parcels and constructed privately at the owner's expense. Sewer plan: RP-9527

Storm: All storm sewers necessary for development/redevelopment of the area shall be designed in accordance with design policy and zoning codes in effect at the time of development.

All sanitary and storm sewers required shall be constructed privately by the owners/developers at their own

expense with no cost to the city.

Section 2. If this 4.00± acre site is annexed and if the City of Columbus permits uses in the annexed territory that the City of Columbus determines are clearly incompatible with the uses permitted under current county or township zoning regulations in the adjacent land remaining within Mifflin Township, the Columbus City Council will require, in the zoning ordinance permitting the incompatible uses, the owner of the annexed territory to provide a buffer separating the use of the annexed territory and the adjacent land remaining within Mifflin Township. For the purpose of this section, "buffer" includes open space, landscaping, fences, walls, and other structured elements: streets and street right-of-way; and bicycle and pedestrian paths and sidewalks.

This ordinance is to authorize the Director of the Recreation and Parks Department to enter a grant application with the Ohio Department of Natural Resources (ODNR) Clean Ohio Trails Fund which will be used to build the Alum Creek Trail / Mock Park-Hudson Street Connector.

Background: ODNR administers statewide grant funding for the construction of trails, and a resolution from the city is required for the grant submittal and agreeing to provide the necessary match funds. If awarded funding, a separate piece of legislation will be submitted at a later date to enter into a grant agreement and allocate the local funds.

The Alum Creek Trail/Mock Park-Hudson Street Connector will become a direct 1.2 mile connection for the Northeast community to the city's regional trail system. The connector will be a 10' paved path from the Alum Creek Trail at Sunbury Road and Mock Road and will extend into the city's new Hudson Street path from I-70 ending near Parkwood Avenue. By linking these two east/west projects, over 6,000 residents and employees of the Arlington Park, Woodland Holt, Brittany Hills, Argyle Park, and East Linden neighborhoods will be within 10 minutes of walking and biking connectivity to parks, churches, schools, retail, and jobs.

BACKGROUND:

On March 2, 2015 a request for proposal SA005789 for city wide e-payments services was issued by the Columbus City Treasurer's Office. One hundred thirty nine vendors were contacted electronically. Proposals were received from three (3) bidders and subsequently reviewed by the Columbus Depository Commission, which recommended, subject to the approval of City Council, the award of e-payment services on January 25, 2016 to First Data Government Solutions. The contract is for a period of ten (10) years beginning March 2, 2016 through March 1, 2026 subject to annual appropriations and approval of contracts by the Columbus City Council.

The contract for the first year of e-payment services was authorized by Columbus City Council by passage of ordinance 0301-2016 on February 22, 2016. City Council also authorized modifications to the contract with First Data on July 11, 2016 (ordinance 1727-2016) to add the Division of Fire and on November 21, 2016 (ordinance 2822-2016) to add the Department of Public Service. The contract for the second year of e-payment services was authorized by Columbus City Council with the passage of ordinance 0276-2017 on February 27, 2017.

City Council authorized the modification of the First Data contract to add funding on behalf of the Department of Public Service and to enable the City Treasurer's Office to take e-payments on behalf of other city divisions with passage of ordinance 1455-2017 on June 12, 2017. On September 18, 2017 City Council passed ordinance 2310-2017 authorizing the modification of the First Data contract to add funds for the departments of Public Safety, Fire Division, Building and Zoning Services, and Public Utilities. Ordinance 2863-2017 passed on November 20, 2017 provided additional funding to the Department of Public Utilities. BACKGROUND: This legislation authorizes the appropriation and expenditure of \$13,000,000 pursuant to the Contribution Agreement with the Confluence Community Authority, which was authorized by Ordinance 1858-2019 and approved by Columbus City Council on July 22, 2019.

The Confluence Community Authority (or "Authority") is a New Community Authority that has been organized pursuant to Chapter 349 of the Ohio Revised Code for the purposes of owning and operating a new stadium for the Columbus Crew SC, undertaking private development activities on property adjacent to the new stadium, facilitating the redevelopment and improvements to the area around the MAPFRE Stadium site that will include a new Community Sports Park and training facility, and developing infrastructure necessary to fulfill the needs of the projects.

On July 1, 2019, pursuant to Ordinance No. 1730-2019, City Council authorized the Development Director to enter into a Development Agreement with Franklin County ("County") and Crew SC Stadium Company, LLC ("Developer") regarding the proposed financing, development, construction, operation and occupancy of the Stadium, the redevelopment of the MAPFRE Stadium site into a practice facility and training complex for Columbus Crew SC and a community sports campus that will include a community recreation facility and playing fields ("Community Sports Park"), and the development of a mixed-use development project adjacent to the Stadium ("Mixed-Use Development"), collectively, the "Project." It was the intent of the City, County and the Developer that immediately upon the formation of the Authority, that the Authority would become a party to the Development Agreement and that the City and the Authority would enter into a Contribution Agreement to provide for the timing and other mechanics relating to all or a portion of the City's Contribution or other amounts to be contributed through the Authority.

As such, Ord 1858-2019 was passed, which authorized the Finance and Management Director, on behalf of the City, to enter into a Contribution Agreement with the Confluence Community Authority. Pursuant to this Contribution Agreement, the City shall contribute funds in the amount of \$38 million to the Authority to pay for Project Costs (other than Stadium Costs). Subject to appropriation by City Council, the City's contribution shall be made as follows:

- -Not later than March 1, 2020, the amount of \$13,000,000
- -Not later than March 1, 2021, the amount of \$12,500,000
- -Not later than March 1, 2022, the amount of \$12,500,000

Emergency action is requested in order to make the payment by the required date in the Contribution Agreement.

BACKGROUND

The Villages offer services/supports to generate lasting economic stability so older adults are able to age in community as they wish. They provide members with indoor/outdoor home maintenance services completed by volunteers, Village Directors, and other providers. Home maintenance poses a challenge for older adults aging in community. In MORPC's 2017 Age Friendly Columbus report, 30% of surveyed older adults indicated "no" or "I'm not sure" when asked if they agreed that they are able to maintain the outside of their home. Home repairs and modifications may extend beyond an older adult's fixed income and jeopardize an individual's ability to remain at home. When capable volunteers are not available, Village Directors seek out vetted service providers to fulfill unmet needs. Service providers are asked to provide a discount to Village members.

This funding will assist The Villages in providing outdoor home maintenance services, including snow removal for the remainder of winter, for older adults in the Downtown, Near East, Hilltop, German Village, Near South, and Clintonville areas. Columbus City Council has been an advocate for the needs of aging residents in our communities, and is supporting this project with \$8,000.00 in funding from the Neighborhood Initiative subfund.

EMERGENCY DESIGNATION: Emergency action is requested in order to immediately provide The Greater Columbus Network of Villages with the support necessary to continue providing these services to residents in need.


WHEREAS, the City intends for the City Attorney to spend City funds to acquire the Real Estate in good faith and contract for associated professional services (e.g. surveys, title work, appraisals, etc.); and

WHEREAS, it is necessary to authorize the expenditure of up to Five Hundred Twenty-five Thousand Dollars (\$525,000.00) from the Sanitary Sewer General Obligation Bond Fund 6109; and

WHEREAS, an emergency exists in the usual daily operations of the Department of Public Utilities in that it is immediately necessary to authorize the City Attorney to acquire the Real Estate in order to prevent unnecessary delay in completing the Public Project, which will preserve the public peace, property, health, welfare, and safety; and now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

- **SECTION 1.** That the City Attorney is authorized to acquire in good faith and accept certain fee simple and lesser real estate located in Northern Pickaway County near Rickenbacker International Airport ("Real Estate") in order for the Department of Public Utilities ("DPU") to timely complete the acquisition of the Real Estate for the Intermodal Sanitary Subtrunk Extension Project (CIP 650491-100007) ("Public Project").
- **SECTION 2.** That the City Attorney is authorized to contract for professional services (*e.g.* surveys, title work, appraisals, *etc.*) associated with the Real Estate's acquisition for the Public Project.
- **SECTION 3.** That the City Attorney, in order to exercise the authority described in Sections One (1) and Two (2) of this ordinance, is authorized to spend up to Five Hundred Twenty-five Thousand and 00/100 U.S. Dollars (\$525,000.00), or as much as may be necessary, from the Sanitary Sewer General Obligation Bond Fund 6109, according to the account codes in the attachment to this ordinance.
- **SECTION 4.** That the City Auditor is authorized and directed to establish any appropriate accounting codes once the funds necessary to carry out the purpose of this ordinance are deemed appropriated.
- SECTION 5. That the City Auditor is authorized and directed to transfer any unencumbered balance in the Public Project's account to the unallocated balance within the same fund upon receipt of certification by the director of the department administering the Public Project that the Public Project is complete and the monies are no longer required for the Public Project, except that no transfer can be made from a project account by monies from more than one source.
- **SECTION 6.** That the City Auditor is authorized and directed to establish any proper and appropriate project accounting numbers.
- **SECTION 7.** That the City Auditor is authorized and directed to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this ordinance.
- **SECTION 8.** That this ordinance, for the reasons stated in the preamble, which are made a part of this ordinance and fully incorporated for reference as if rewritten, is declared to be an emergency measure and shall take effect and be in force from and after this ordinance's adoption and approval by the Mayor or ten (10) days after its adoption if the Mayor neither approves nor vetoes this ordinance.

All members shall be appointed by the Mayor with the concurrence of City Council.

Section 1. There is hereby created in the city of Columbus a Commission area to be known as the North Linden Area Commission, hereafter in this document referred to as the Commission.

Section 2. This area shall be bounded and described as follows: Beginning at the intersection of the centerline of the railroad right-of-way west of Joyce Ave. and Hudson St. and proceeding in a westerly direction along the center line of Hudson St. to the first north-south railroad right-of-way immediately east of Indianola Ave.; thence proceeding in a northerly direction along the centerline of the railroad right-of-way to Cooke Rd.; thence proceeding in an easterly direction along the centerline of Cooke Rd. to Karl Rd.; thence proceeding in a northerly direction along the centerline of Karl Rd. to Ferris Rd.; thence proceeding in an easterly direction along the centerline of Ferris Rd. to the north-south railroad right-of-way west of Joyce Ave.; thence proceeding in a southerly direction along the centerline of the railroad right-of-way to the point of beginning.

ARTICLE II. PURPOSE

Section 1. These Bylaws shall establish the proceedings by which the North Linden Commission shall execute its duties functions under the grant of authority set forth in Chapter 3313 of the Columbus City Code.

Section 2. This Commission is established to afford citizen participation in the decision-making process functioning in an advisory capacity and to facilitate communication, understanding and cooperation between neighborhood groups, city officials and developers.

ARTICLE III. MEMBERSHIP

Section 1. There shall be maximum of 45 9 members of the Commission. All members shall be appointed by the mayor with concurrence of City Council.

- a) Ten (10) Seven(7) persons living in the Commission area shall be selected as resident members by the selection procedure outlined in Art. III, Sect. d. For selected members running for consecutive selected terms, the signatures of 25 residents within the area are not required.
- b) Four (4) Two (2) members, who need not be area residents but who have shown a demonstrated interest in the area, shall be nominated by the selected members of the Commission.
- c) One(1) member shall be appointed by the Mayor from his/her Cabinet or staff or other agreed upon city employee.

- c) For selected members running for consecutive selected terms, the signatures of 25 residents within the area are not required.
- d) Except as otherwise specified, all members have equal rights.
- e) All members shall serve without compensation

Section 2. Selection, Terms, Vacancies

- a) Initially, terms shall be determined by lot with five (5) selected, two (2) nominated members and the Mayor's appointee serving for a term of three (3) years, four (4) selected and three (3) nominated serving for a term of two (2) years.
- b) Thereafter, all terms shall be for a period of two (2) three (3) years, staggered with four (4) of the commissioners' terms expiring on even years on a given year and three (3) on odd years.commissioners terms expiring on a different year.
- a) All members shall serve without compensation.
- c) Each term shall end on December 31 of the year the term expires.
- <u>After the selection of initial Commissioners, selection of subsequent commission members shall</u> <u>be by residents of North Linden by petition and election.</u>
 - i. Candidates must submit a resume, short biography, essay, and petition with signatures of at least 25 North Linden residents.
 - ii. Availability of petitions will be announced at the regular June and July meetings and published in available media.
 - iii. Petitions are due by the second Thursday in August.
 - iv. Candidates must be 18 years of age or older and be a North Linden Resident
 - v. Signers of petitions must be 18 years of age or older and be residents of North Linden.
 - vi. Petitions must contain 25 or more valid signatures for a candidate to be considered for selection.
 - vii. An election shall take place annually in the month of September.
 - a. All valid candidates, (Article III, Sect. 2d, i-vi), shall be placed on the ballot.
 - b. Election shall be by secret ballot. All North Linden residents and Commissioners attending the September meeting may cast a ballot.
 - viii. No election shall be scheduled if the number of candidates is less than or equal to the number of selected Commissioners with expiring terms.

b)e) Any vacancies caused by death, resignation, disqualification, or by other means shall be filled for the unexpired term by appointment of the Mayor with the concurrence of Council. The area commission may recommend appointees to the Mayor to fill vacancies. Candidates for appointment must submit a resume, cover letter, and qualifying petition (ARTICLE III, Sect. 2d, i,iv-vi)

e) A commission year begins on July 1.

f) A commissioner who is elected or appointed to a seat may not be elected or appointed to a different seat until the term of the seat held by the commissioner has expired.

Section 3. Expectations and Responsibilities of Commissioners

- a) No member shall represent the Commission in its official actions except as specifically authorized by a majority vote at a regular or special meeting. This shall not be construed as a restriction upon the rights of individual members to represent their own views before public or private bodies, whether in agreement or disagreement with the official actions of the Commission.
- b) Statements made by Commissioners outside of official meetings, including on social media, do not represent the Commission unless the Commissioner has been directly authorized by position or vote to represent and speak on behalf of the Commission.
- c) When presenting personal views before public or private bodies or on social media, Commissioners should clarify that they are not representing or speaking on behalf of the Commission.

Section 4. If a member of the Commission selected by the selection procedures moves out of the described Commission area, such member must relinquish his or her resident status in writing and be replaced per Section 2be. Resignation will be officially announced at the next public meeting.

Section 5. Attendance

Section 5. Attendance

a) Commissioners are required to attend all meetings of the Commission, including planning meeting.

b)Unexcused absence from two (2) consecutive regular meetings or from any total of four (4) regular meetings in any 24 month period shall be considered as an automatic resignation from the Commission. The Secretary shall give prior notice to members after any member's unexcused absence. Any combination of more than six (6) total excused and unexcused absences from regularmeetings during any 24 month period will be brought before the Commission for consideration of requesting a resignation. Notice of a resignation together with the Commission recommendation shall be sent to the Mayor and the City Clerk.

- b) Commissioners who communicate an absence to the Chair prior to a public meeting will be deemed excused. Except for emergency, Commissioners are not permitted to have more than three (3) consecutive excused absences.
- c) Commissioners who fail to communicate absence to the Chair prior to a public meeting will be deemed un-excused. Two (2) consecutive unexcused absences from regular monthly meetings (Art. V, Sect.1) or from four (4) regular monthly meetings in a 12 month period are in violation of Sect. 5a.

d) A Commissioner in violation of part (b) or (c) of this section will be officially removed by the Commission at the next regular meeting.

ARTICLE IV. OFFICERS

Section 1. The Officers of the Commission shall be Chairperson, Vice-chairperson, Secretary and Treasurer.

Section 2. Officers shall be elected by a majority of the Commission members present at the first scheduled meeting after the election with officers taking office at the following meeting.

Section 3. Each Officer shall be elected for a term of one (1) year, or until his or her successor is elected.

a) So as to eliminate any possible conflict of interest, the Mayor's appointee shall not hold a Commission office.

Section 4. The duties of the officers shall be:

- a) The Chairperson shall preside at meetings of the Commission, prepare the agenda for Commission meetings, and, in consultation with the other Commission members, appoint standing and/or select committees of the Commission.
- b) The Vice-Chairperson shall perform the duties of the Chairperson in the Chairperson's absence and shall perform such special duties that may arise from time to time at the request of the Chairperson.
- c) The Secretary shall call and record the roll; record all votes and take minutes of Commission meetings; distribute minutes to Commission members; maintain a file of minutes and such other records as the Commission may direct; maintain a permanent record of the names, addresses and telephone numbers of all Commission members; and notify the Mayor of vacancies. Minutes of all Commission meetings shall be opened to the public's examination.
- d) The Treasurer shall receive and submit all Commissioners' requests with receipts for reimbursement; and shall receive and disburse all funds of the Commission.
- **Section 5.** A vacancy in the Chairperson position shall be filled by the Vice-Chairperson. A vacancy in every other position shall be filled in the manner previously described (Article III, Sec.1 and 2, Article IV, Sec. 2 &3) A vacancy filled for six (6) months or more shall be considered full term.

Section 6. Any election required in these Bylaws shall be conducted by secret ballot.

ARTICLE V. MEETINGS

Section 1. Regular Meetings

- a) Regular meetings shall be on the third Wednesday of each month at a stated time to be determined by two-thirds vote of the Commission (10) and shall be open to the public. Regular meetings shall commence no later than 15 minutes after the stated time.
- b) The first regular meeting in June shall be the Annual Meeting at which time the new Commissioners shall take office, officers shall be elected and annual reports from committees will be received.
- c) A regular meeting may be cancelled, or the meeting date changed, by a two-thirds vote of the Commission.

Section 2. Special Meetings

- a) Special meetings may be called by the Chairperson or by a majority of members present in a regular or special meeting or by the Chairperson at the written request of at least five (5) members.
- b) Written notice of any special meeting shall be given to each Commission member and the public at least three (3) days in advance, except in an emergency. This written notice shall specify the date, time, and place of the meeting and describe all business to be conducted at the meeting.
- c) No business shall be conducted at a special meeting unless it was included in the notice of the special meeting.
- d) Special meetings shall be open to the public.

Section 3. Quorums

A quorum shall consist of eight (8) Commissioner memebers. A majority of the Commission members present and voting shall be required to approve a motion, except as otherwise provided.

Section 4. The business of the Commission shall contain the following unless otherwise directed by a majority of members present:

Section 5. The Chairperson may recognize members of the public who wish to address the Commission concerning issues under discussion. A uniform time limit for such presentations may be set by the Chairperson.

Section 6. When guests are invited to speak to the Commission the time will generally be limited to thirty (30) minutes or at the discretion of the Chairperson.

Section 7. Dissenting or non-concurring reports may be filed with the Secretary by Commission or committee members and shall be attached to the majority report.

Section 8. Commission meetings shall be limited to not more than three (3) hours unless deemed appropriate and approved by a majority of the Commission members present.

Section 9. Except as otherwise specified, meetings of the Commission shall be conducted according the latest current revision of Robert's Rules of Order.

ARTICLE VI. COMMITTEES

Section 1. Appointment of Commission members to both standing and special committees shall be made by the Chairperson in consultation with Commission members and shall be subject to the approval of a majority of the Commission members.

Section 2. Each standing committee may appoint persons who are not Commissioners or members, subject to the approval by the Commission. All committee members have voting privileges within that committee. Non-commissioners shall not outnumber Commissioners on any standing committee.

Section 3. Each committee shall select a member to Chair the committee, and may select other Officers and adopt internal rules necessary to carry out their assigned task. The selected Chairperson of any committee shall be a Commissioner.

- a) The selected Chairperson of any committee may be requested to step down as the Chair of that committee by (1) the Commission Chairperson or (2) a member of that committee.
- b) The selected Chairperson of any committee may be voted out as the Chair of that committee by (1) a two-thirds majority vote of that committee's members or (2), upon the recommendation of the Commission Chairperson, by the entire Commission with a two-thirds majority vote of the Commission members present.
- c) Voting by the entire Commission, for the purpose of removing a selected Chairperson of a committee shall be conducted at a Special Meeting of the Commission, with all interested parties invited. The voting shall be by secret ballot.
- d) At any time before voting by the entire Commission, for the purpose of removing a selected Chairperson, that selected chairperson may resign the chair.

- e) Leaving the committee is the decision of the individual member. If the member remains on the committee, he/she shall not publicly represent the committee or the Commission in a position of authority with regard to that committee or any of that committee's functions. He/she is an internal member only on that committee.
- **Section 4.** A special committee may be established or dissolved by a majority vote of the Commission. Its size, powers and duties shall be specified by the creating resolution.
- **Section 5.** Notice of all committee meetings and copies of all committee correspondence shall be filed with the Secretary/Clerk and Chairperson of the Commission.
- Section 6. The Chairperson of the Commission shall be an ex-officio member of all committees.

Section 7. The standing committees and their responsibilities are:

- a) Executive Committee
- 1. Consists of Chairperson, Vice Chairperson, and Secretary; and
- 2. Prepare the agenda of regular meetings; plan the direction and scope of Commission activities.
- b) Planning & Development Committee
- 1. Review & recommend long-range plans;
- 2. Investigate funding for implementation of such plans;
- 3. Develop methods for involving the citizens in such planning; and
- 4. Maintain planning files.
- c) Zoning Committee
- 1. Receive, review and make recommendations concerning applications for rezoning, zoning variances and special permits for property located in the area.
- d) Community Service Committee
- 1. Review social and recreation services in the area and take appropriate action to improve or maintain them;
- 2. Attempt to improve or maintain employment and education opportunities for residents of the area;
- 3. Monitor consumer business relations in the area;
- 4. Initiate, coordinate or assist at community-wide events;
- 5. Work to develop a community identity;
- 6. Work to improve the quality of life for all our residents; and
- 7. Publicize the North Linden Area Commission as a community resource.
- e) Code Enforcement Committee
- 1. Report known code violations in the North Linden Commission area to the appropriate Code Enforcement officer of the City of Columbus;

- 2. Become knowledgeable about code enforcement problems in the community and make constructive suggestions about remedying them; and
- 3. The Committee may undertake programs to educate the community about code enforcement issues.
- f) Safety Committee
- 1. Coordinate and/or initiate efforts to reduce crime in the community. Work with other groups as desired;
- 2. Initiate and/or help with efforts to maintain a clean community;
- 3. Initiate and/or assist with efforts to control conditions which interfere with the health of residents; and
- 4. Initiate and/or assist with efforts to alleviate vehicular traffic problems in the community.

ARTICLE VIII. AMENDMENTS

Section 1. A proposed amendment to these Bylaws shall be submitted in writing by any Commission member at any regular meeting.

- a) The proposed amendment shall first be read at the regular meeting when submitted and again at the next two (2) regular meetings following. The proposed amendment shall be voted on after the reading at the third regular meeting.
- b) With a unanimous vote of the Commission members present at the first reading, the proposed amendment may be voted on at the next regular meeting.
- c) Adoption of the proposed amendment shall be by a two-thirds majority vote of the entire Commission.

Section 2. In accordance with Chapter 3313 of the Columbus City Code, the approved amendment shall be filed immediately with the City Clerk after its adoption. Such amendment shall take effect thirty (30) days after publication in the City Bulletin

ARTICLE IX. PARLIAMENTARY AUTHORITY

Section 1. The rules contained in the current edition of "Robert's Rules of Order Newly Revised" shall govern the Commission in all cases to which they are applicable and in which they are not inconsistent with these Bylaws and any other special rules of order the Commission may adopt.
